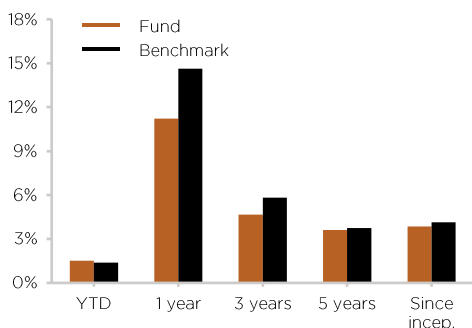
Risk Indicator Definition

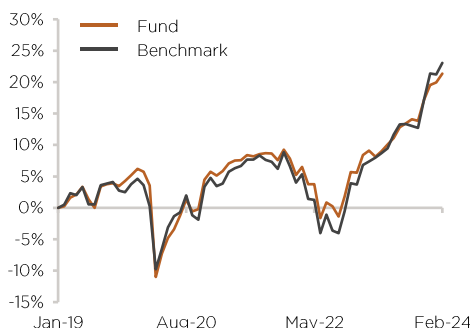
RISK INDICATOR

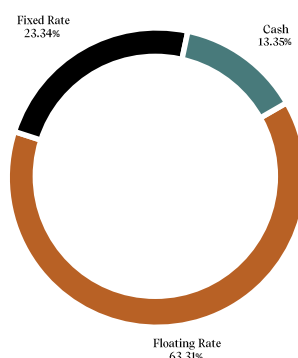

MARKET COMMENTARY

Market dynamics:

The iTraxx Crossover 5-year spread index rallied some 20 basis points (bps) during the period to end the month at 306 bps. It was another low volatility month, and when coupled with the 12 bps sell-off during January, it would appear that 2024 is setting itself up to be a year where spread capture is the name of the game. In total return terms, the index produced 1.53%, which more than makes up for the 0.14% loss in January. The year-on-year number is still looking healthy at 14.63% in euros. Our more favoured two-times levered index delivered 2.76% on the month and has shown investors who have a bit more risk appetite a rather pleasing 26.30% on a year-on-year basis. We continually reference this levered index because it has delivered volatility in line with equities, so it becomes a more comparable performance set.

No credit events were reported via Markit during the month, so the calendar remains default-free, with the last meaningful default announced in October last year.

The Fund, being structured more defensively, delivered 1.17% on an after-fee basis, underperforming the index by around 0.37%.

We opted to redeem GBP 600 000 (50% of our holding) of our Investec Contingent Convertible bonds at a clean price of 99% of par. We purchased this back in March 2020 and paid 95.06% all-in. Over the holding period, it has provided us with a fixed annual coupon of 6.75%, paid quarterly.

We added a marginal EUR 100 000 position to the Fund, which references iTraxx S40 and pays a quarterly coupon of three-month EURIBOR + 7.05%. This should add approximately an extra basis point to the portfolio spread, which currently sits at 340bps.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

High Water Mark: The highest level of performance achieved over a specified period.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (% PF (%)): The Performance Fee is a payment made to the Fund Manager for generating positive returns and is generally calculated as percentage of investment profits, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Specific Risk
