#### **Investment Objective & Strategy**

The **Wealthstrat Worldwide Flexible Prescient Fund of Funds** will aim to deliver a high level of capital growth. The manager shall have maximum flexibility in terms of asset allocation and shall not be precluded from continually varying the underlying exposure to both local and offshore assets. The fund will employ asset and geographical allocations to reflect changing economic and market conditions to maximise returns over the long term, the **Wealthstrat Worldwide Flexible Prescient Fund of Funds** will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The underlying portfolios will predominantly invest in offshore jurisdictions subject to the investment conditions determined by legislation however investments in South African Markets may be included from time to time.








#### **Equity Regional Exposure**

#### **Quarterly Fund Commentary**

Aggressive investors generated positive returns in the fourth quarter of 2024. However, both local and global risk assets struggled over the quarter, posting relatively weak returns. In contrast, the depreciation of the rand during the quarter provided a favourable tailwind to the Portfolio's global allocations.

The WealthStrat Worldwide Flexible Prescient Fund of Funds returned +3.5% for the quarter and has generated a return of +12.1% over the past year.

The portfolio retains a strong bias toward global and local equities, which we expect to deliver significant inflation-beating returns in the long term.

#### Asset Allocation

Global equities produced divergent returns over the fourth quarter. Within equities, allocations to the broad US market, Financials and US Small-Cap stocks contributed positively to performance, given that these were amongst the few parts of the market that managed to end in positive territory over the quarter on the back of expectations that they would be key beneficiaries of a second Trump presidency. Turning to other regions, Emerging Market equities came under pressure this quarter, particularly Korean and Chinese equities. In addition, the Eurozone and UK detracted from performance of the Resource sector (-9.0%). Platinum and gold miners including Impala Platinum (-9.3%), Anglo American Platinum (-8.3%), AngloGold Ashanti (-8.3%) and Gold Fields (-8.1%) detracted from performance on the back of weaker commodity prices and general weakness in the sector. In addition, poor performance from the larger banking constituents including FirstRand (-6.0%) and Standard Bank (-8.5%) led the Financial (-1.2%) sector lower over the quarter. However, the Financial sector was the best-performing sector in 2024, posting a robust 22.4% return. Strong performance from Pepkor (+20.2%), Mr Price (+10.4%), and Spar (+7.8%) led the Industrial sector (+2.7%) higher this quarter. Local bonds make up the next largest allocation within the Portfolio. South African bonds showed resilience in the fourth quarter, advancing 0.4%, despite December's pullback. The bond market's strong performance stood out among asset classes during this period, capping off an exceptional year. Generally, nominal bond yields were supported by moderating inflation, the South African Reserve Bank (SARB) continuing its rate-cutting cycle and improving investor sentiment stemming from early positive developments following the formation of the Government of National Unity (GNU). Local cash allocations continued to deliver positive returns this quarter. Conversely, offshore bond allocations experienced headwinds during the quarter. The U.S. Federal Reserve ado

#### Fund Selection

The contribution from fund selection was mixed for the guarter.

The PSG Equity Fund faced challenges during the quarter, delivering weak fourth quartile performance and underperforming the majority of its peers. The fund's underperformance was primarily driven by the allocation effect, as sector allocation decisions negatively impacted returns. Key detractors included allocations to resource companies such as Glencore (-15.5%), AECI (-15.5%), Northam Platinum (-10.7%) and AngloGold Ashanti (-5.1%). The fund remains overweight in Energy, Materials and Industrials, while underweight in Consumer Discretionary, Consumer Staples and Financials.

BCI Fundsmith Equity FF delivered fourth-quartile performance over the fourth quarter, with returns that were behind the MSCI World benchmark and the ASISA Global Equity General peer group. The main detractors over the quarter came from the fund's Health Care positioning, as a large holding in Novo Nordisk (-26.4.0%) in particular detracted over the quarter. Other detractors in the fund included consumer-orientated positions in L'Oreal (-21.1%), LVMH (-18.2%) and Nike (-14.0%) which overshadowed contributing positions over the quarter, such as Visa (+15.2%), Alphabet (+14.3%) and Marriot (+12.5%).

The Fairtree Equity Prescient Fund faced significant headwinds in the fourth quarter, trailing most of its peers and delivering a subdued fourth quartile performance. The fund's underperformance was primarily driven by poor stock selection, with weak performing securities across several sectors weighing negatively on returns. Additionally, sector allocation decisions further detracted from performance, particularly the fund's overweight positions in materials and consumer staples, which delivered disappointing results. Key detractors from the broader resource sector included allocations to Sasol (-28.2%), Kumba Iron Ore (-18.6%), Glencore (-15.5%), Harmony Gold (-14.9%) and Gold Fields (-8.1%). This combination of suboptimal stock selection and sector allocation hindered the fund's ability to perform competitively during the quarter.

There were no changes made to the underlying funds in the portfolio in the fourth quarter.

#### Summary

We are pleased that the portfolio delivered a positive return over the fourth quarter, despite mixed local market performance. We remain comfortable with the positioning of the Portfolio, both from an asset allocation and a manager selection perspective. The portfolio continues to have a large allocation to global and local equities, which we expect to deliver significant inflation-beating returns over the long term. The fund has adhered to its policy objective.

#### Glossary

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

#### **Fund Specific Risks**
