INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve significant real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - High Equity funds over a full market cycle by maintaining meaningful exposure to growth assets like equities.

INVESTMENT PROCESS

The Fund invests across a range of assets including equities and interest bearing instruments, both domestically and offshore. The asset allocation is anchored at the long-term strategic allocation, but can be varied tactically to target outperformance of the benchmark by capitalising on signals of significant market mispricing. Where possible, a process of enhanced indexation is utilised within asset classes to deliver stable incremental alpha.

WHO SHOULD INVEST

Investors seeking significant real returns over the long term but who are cost conscious. The Fund is suitable for investors with a medium to long-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically exhibit more volatility and potential for capital losses due to higher exposure to equities and exposure to offshore markets where currency fluctuations may result in capital losses. These portfolios typically target returns in the region of 5% - 6% above inflation over the long term.

FUND COMMENTARY

In the United States, a growing economic divide is emerging between higher- and lower-income households as businesses begin passing tariff-related costs onto consumers. These costs stem from the trade policies introduced during the Trump administration. While inflation is rising, it remains below previous peaks. The situation has been further complicated by a federal government shutdown, caused by a political deadlock over budget negotiations. As a result, the Labour and Commerce Departments announced that their statistical agencies would halt the release of key economic data. This includes employment figures for September, construction spending data, and possibly international trade statistics for August. The Bureau of Labour Statistics, Census Bureau, and Bureau of Economic Analysis have all ceased operations until funding is restored.

Europe, meanwhile, continues to feel the effects of the destruction of the Nord Stream pipelines. Germany's economy has stalled, with factory output weakening and unemployment rising to the highest level in a decade. Rising energy costs, interest rates, and structural challenges continue to weigh heavily. France is also under pressure, with its government collapsing over severe budget deficits - currently among the highest in the developed world - raising alarms about the fiscal stability of the eurozone. In contrast, Japan's economy has shown surprising resilience. The Japanese equity market has shown a positive trend with the Nikkei 225 gaining 5.18% in September.

Back in South Africa, the South African Reserve Bank (SARB) also kept its repo rate unchanged at 7%, despite subdued inflation. The SARB is working with the National Treasury to establish a de facto inflation target of 3%, aimed at enhancing policy credibility and laying the groundwork for future rate cuts. However, economists remain divided. Some view the decision as a missed opportunity for economic stimulus, while others stress the need for structural reforms beyond monetary policy. Governor Lesetja Kganyago stated that headline inflation is expected to climb in the coming months, peaking at around 4%. Projections for food and services inflation have been revised upward, though partly offset by a stronger exchange rate. The SARB now expects headline inflation to average 3.4% in 2025 and 3.6% in 2026, before returning to the 3% target in 2027.

South Africa posted modest GDP growth of 0.8% in the second quarter, slightly exceeding expectations. Growth was led by mining, which rose by 3.7%, and manufacturing, which increased by 1.8%. However, the outlook remains concerning. Unemployment rose to 33.2%, gross fixed capital formation declined for the third consecutive quarter, and the construction sector contracted by 0.3%, all of which raise questions about the sustainability of the recovery.

Overall, it has been a good month for equities, with both the MSCI World (+3.2%) and MSCI Emerging Markets (+7.0%) posting positive gains. In South African markets, South Africa's resource companies, particularly gold mining companies, performed strongly in September, while the technology sector experienced a decline. Overall, the Top40 returned 7.8% while bonds and ILBs were up 3.2% and 3.0% respectively.

Fund performance was strongly positive for the month due to continued very positive performance of local equities.

The Fund currently holds a moderately negative view towards South African and developed market equity and local bonds. Our view on the rand also remains moderately negative.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
