INVESTMENT OBJECTIVE

To provide strong long-term capital growth to investors and target returns in excess of CPI+5% over rolling 10-year periods. This fund is primarily invested in global equity assets while the return and risk profile is expected to broadly reflect that of global equity markets.

- Actively managed fund solution that primarily invests in global equity markets. It will have marginal exposure to other asset classes from time to time.

RISK INDICATOR AND WHO SHOULD INVEST

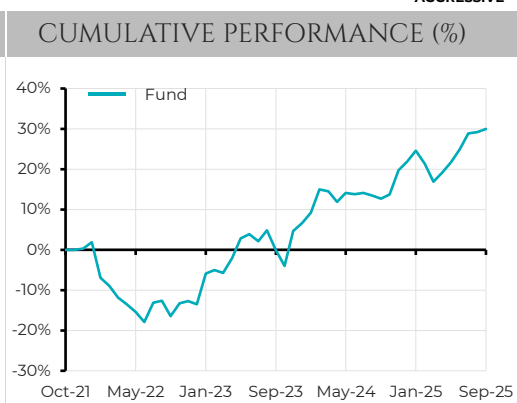

RISK INDICATOR



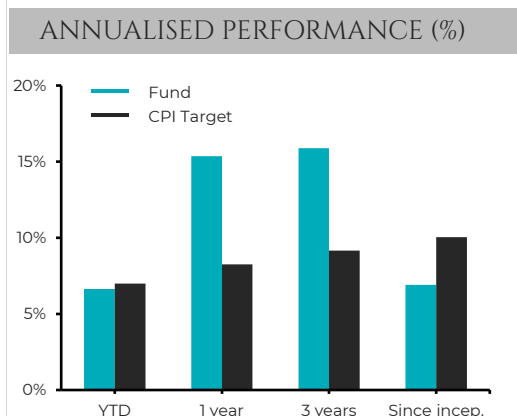

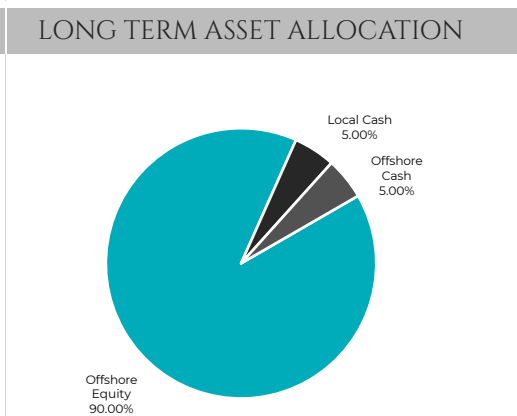

FUND COMMENTARY

Looking at SA asset classes over the most recent 1 year, the Capped Swix was up 28.1% and the All Bond Index returned 14.5%. Offshore asset classes, the MSCI All Country World Index was up 17.8% (SA asset classes are in rands, while Offshore asset classes are in US Dollars). The Rand over the last 1 year vs the USD was basically flat. Looking at global investment markets in September: Investment markets in September 2025 were characterised by a robust rally in equities, particularly in the US and emerging markets, a supportive move in bond markets following a US Federal Reserve rate cut, and a significant surge in the price of gold.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
