



FUND OBJECTIVE & STRATEGY

The ClucasGray Equity Prescient Fund is a SA only, general equity fund. The Fund aims to provide long term capital growth ahead of its benchmark (SWIX) and the competing unit trust category by investing in any shares that are listed on the JSE. The Fund is a high conviction fund aiming to hold no more than 25 stocks at any one time. Fundamental analysis, a valuation discipline and a belief that inefficient markets create opportunities in mispriced assets underpin our process.

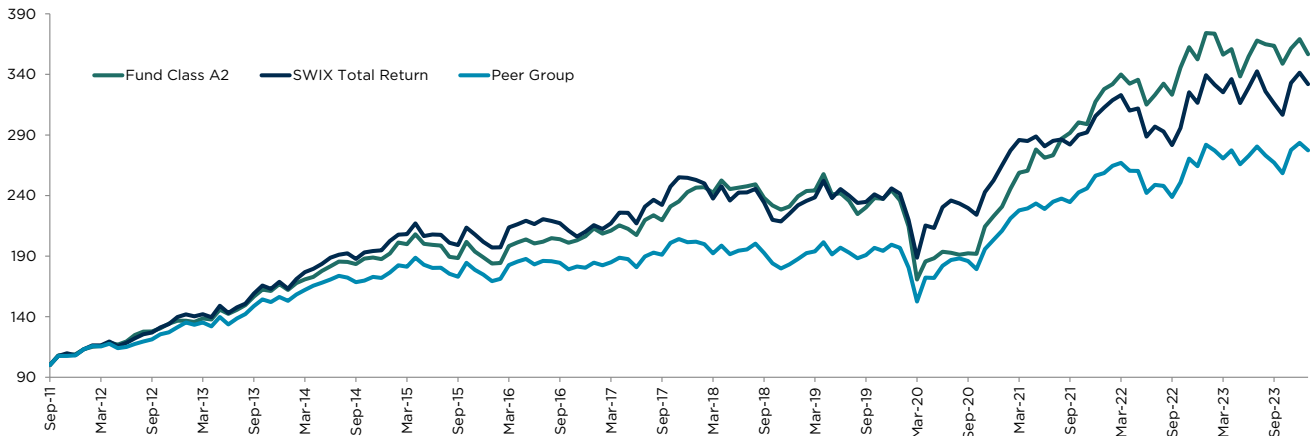

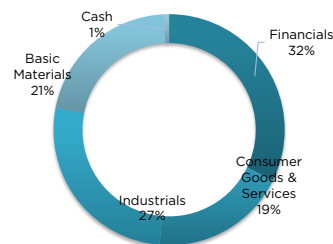

QUARTERLY COMMENTARY | DECEMBER 2023

The ClucasGray Equity Prescient Fund gained 4.7% in 2023, behind both the JSE Swix and the peer group returns of over 7%. Over the last 3 years, the fund has delivered compound annual returns of 18.3%, which compares favorably to the JSE Swix of 10.6% and the peer group of 11.7%. Over all longer periods the fund has outperformed both peers and the Swix.

In the 9 months to the end of September 2023, the ClucasGray Equity Prescient Fund had performed well – outperforming the peers and JSE Swix by 2% and 3% respectively. The final quarter proved more tricky. The fund gained 1.5%, lagging the peers (6.1%) and the JSE Swix (8.0%) quite meaningfully. Large names we didn't hold performed well – Amplats (+37%), Goldfields (+35%) being the standouts. A number of our key holdings did perform well, including The Kal Group, African Rainbow Minerals, Standard Bank, Momentum, TFG Holdings, MultiChoice, Old Mutual and FirstRand all gained over 8%. However, more than countering these, certain holdings lagged – most notable was Sasol which declined 29% following an underwhelming trading update. Other laggards included Absa, Anglos, British American Tobacco, Impala and Life Healthcare, all of which declined over 5% in the quarter.

2023 has brought with it a slew of issues, including, but sadly not limited to the unwelcome return of Stage 6 loadshedding, Transnet inefficiencies at our Ports and Rail network, a sluggish economy, a very weak currency and elevated interest rates. The sustained and elevated levels of loadshedding has been an economic standout. Statistics show that by the middle of December, the country had endured 332 days of loadshedding – power filled days a rarity. The adverse consequences of loadshedding have been well document by many, suffice to say that it presented a very difficult backdrop for households and businesses.

None of us know for certain when South Africa will have resolved its power issues, if ever. We do know that most large businesses, and a growing number of households, have invested in alternative energy sources, hence reducing the impact of loadshedding. Coupled with the forecast for a significant amount of power being imminently added to the grid, we believe the operating environment will become a little easier into 2024.

Given the significance of the impact on near term earnings, we believe investors are better served focusing on a more normalized earnings base to value companies. Less dramatic, but similar to the Covid crisis where 2020 earnings were of academic interest only, we believe the loadshedding impacted earnings of 2023/24 reporting season will be artificially suppressed for many companies. As the power crisis alleviate, we expect many of our companies will see an improvement in earnings over the next 2 years.

Guided by our investment process, we have endeavoured to buy good companies at what we think are very attractive prices. Our estimate is the weighted forward PE multiple of the ClucasGray Equity Prescient Fund is currently 8x, with the weighted Dividend Yield being 5.5%. In addition, more than half of the portfolio companies, by weighting, are busy with either share buy backs or special dividends. Our assessment of the potential prospective 3 year compound returns the portfolio could deliver are well in excess of the equity risk premium. As written extensively over the last while, we believe catalysts will emerge to unlock what is, in our view, extraordinary value in select sectors and companies.

The Fund has adhered to its policy objective.
