### INVESTMENT AND RETURN OBJECTIVE

The underlying Fund aims to generate real return in US Dollars and is benchmarked to the US inflation rate, converted to Rands.

### INVESTMENT PROCESS

The investment universe includes fixed, floating, real and nominal money market and bond market investments, property, derivatives and global currencies. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes, the use of derivatives and currency management.


### WHO SHOULD INVEST

Investors seeking a hedge against any rand depreciation while gaining exposure to high yielding offshore assets that are not available locally in South Africa. Although this is a roll-up fund and does not distribute income, it is suitable to investors with a medium to long-term investment horizon who wishes to fund income withdrawals by redeeming units, due to the exposure to yield generating assets held in the Fund and therefore a lower probability of selling underlying units at inappropriate times such as in a market downturn.


### RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

## FUND COMMENTARY

Global fixed-income markets remained broadly constructive in February as investors continued to gain confidence that major central banks are approaching the later stages of the tightening cycle. In the United States, incoming economic data pointed to moderating growth and continued progress in inflation, reinforcing expectations that the Federal Reserve is likely to begin easing policy gradually later in the year. US Treasury yields experienced modest volatility during the month but remained broadly stable, with movements largely reflecting the balance between resilient economic activity and growing expectations of policy easing.

Across other developed markets, central bank communication remained cautious but increasingly supportive of duration. Policymakers continued to acknowledge progress in bringing inflation lower while emphasising that policy decisions will remain data dependent. Overall rate volatility declined slightly during the month, contributing to a stable backdrop for global fixed-income assets.

Credit markets started showing cracks as the Blue Owl stress hit certain segments. Investment-grade spreads remained near cycle lows, supported by strong corporate balance sheets and sustained investor demand for high-quality income. High-yield markets were mixed during the month, benefitting from stable risk sentiment and contained market volatility, although valuations remain relatively tight.

Within the Fund, we maintained a disciplined and diversified approach to global income allocation. Positioning continues to favour high-quality assets, with an emphasis on floating-rate and shorter-duration exposures where carry remains attractive and capital volatility is lower. At the same time, the Fund retains flexibility to selectively add duration as policy easing becomes more clearly established. We continue to hold duration exposure in the US 5-year and US 10-year Treasury bonds, which we believe offer attractive risk-adjusted return potential should global growth continue to moderate.

Overall positioning remains balanced, prioritising capital preservation, stable income generation, and the ability to capture opportunities as global rate cycles evolve through 2026.

The Fund's forward yield remains attractive at 4.70%, with an interest rate duration of 2.47 years. The portfolio's current risk portfolio aligns with the Fund's risk objective, and we believe the Fund is well positioned to achieve its return objectives.

The Feeder Fund under-performed the underlying fund due to the strengthening of the ZAR during the month.

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.

**Forward Yield:** The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

**Bid Price:** The price a buyer is willing to pay for a security.

**Offer Price (Ask Price):** The price a seller is willing to accept for a security.

**Bid/Offer Spread:** The difference between the offer and bid prices, indicating market liquidity.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
