INVESTMENT AND RETURN OBJECTIVE

The Fund aims to consistently achieve returns above the (ASISA) South African General Equity category over the medium to long term. The Fund is managed systematically to outperform the peer group average return whilst maintaining similar risk characteristics.

INVESTMENT PROCESS

The Fund uses quantitative techniques to dynamically construct a portfolio that is most representative of the general equity category average then employs uncorrelated return enhancement techniques combined with efficient and cost-effective portfolio construction methods to generate outperformance. Although the fund is always fully exposed to the equity market, the use of fixed interest portable alpha techniques to enhance returns can provide exposure to cash and money market instruments, which are uncorrelated and reliable sources of additional return.

WHO SHOULD INVEST


Investors seeking broad based exposure to the South African equity market with consistently above average returns. This Fund is appropriate for investors with a long-term investment horizon.

RISK INDICATOR DEFINITION




FUND COMMENTARY

Trade policy uncertainty, slowing growth expectations and monetary policy recalibration took centre stage during this year's first-quarter market performance exhibition. Developed Market equities, with the MSCI World Index down 4.45% and 1.79% for the month and quarter respectively, were dragged lower by the US to close behind the broad Emerging Markets as the MSCI Emerging Markets Index closed 0.63% and 2.93% higher for the month and quarter. The largely solid quarterly earnings growth numbers reported in the US were overshadowed by a looming tariff-shaped trade war cloud hovering directly over economic growth prospects and potentially resulting in higher prices and elevated interest rates. In what was its worst month in over two years, the S&P 500 Index gave back 5.63% for the month to close the quarter 4.27% lower.

European markets, on the other hand, have continued to advance on the back of an improved fiscal outlook - particularly in infrastructure and defence spending - which, together with two interest rate cuts delivered by the ECB during the quarter, helped the Euro Stoxx Index post impressive gains of 0.92% for the month and 12.49% for the quarter. Asian markets, overall, have been underwhelming this period. The stronger Japanese yen continued to hamper that equity market as the Nikkei 225 Index closed 3.84% and 6.40% lower for the month and quarter. Despite some excitement towards China's technology sector, mainland shares closed the quarter lower with the CSI 300 Index down 2.21% and 0.64% for the month and quarter.

Despite the widening cracks in the Government of National Unity over the country's fiscal framework and significant downward revisions to the rate of monetary policy easing, the domestic equity market continued to make new highs as valuations and business sentiment remained favourable. The FTSE/JSE All Share Index posted solid returns, up 3.55% for the month to close the quarter 5.94% higher. The resources sector was the standout sector with the index advancing 19.54% and 32.26% for the month and quarter respectively.

The Fund maintains the maximum effective exposure to the large- and mid-cap sectors of the market. This equity exposure consists of top three allocations to the financials, basic materials, and technology sectors, with the largest share exposures to Naspers, FirstRand Bank, and Gold Fields.

We remain moderately positive on SA equities with a marginally weaker valuations indicator countered by a marginal improvement in sentiment. Our US equity outlook has moved from neutral to moderately negative, underpinned by deteriorating economic and sentiment indicators.

The Fund has delivered returns ahead of the benchmark index over the last month. This performance is in line with the investment process and systematic risk managed investment philosophy employed to deliver consistent long-term outperformance.

The top contributors to the Fund's performance in March were Gold Fields (26.70%), AngloGold (33.43%) and Harmony Gold (47.86%). Detractors included Richemont (-15.13%), Anglo American (-5.39%), and Nedbank (-8.06%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
