INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI Emerging Markets Index Total Return at low cost. Although the Fund is structured similarly to the MSCI Emerging Markets Index, it is not a tracker fund and can out / underperform the MSCI Emerging Markets Index by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment process which firstly endeavours to follow the composition of the MSCI Emerging Markets Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI Emerging Markets Index or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST


Investors who are seeking long term capital growth through diversified exposure to the global markets by investing in a fund with a low tracking error relative to the MSCI Emerging Markets Index and who are cost conscious.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Global equity markets delivered a more muted performance in November, with strong third-quarter earnings largely offset by increasingly cautious investor sentiment. The MSCI World Index rose 0.28% for the month, while the MSCI Emerging Markets Index declined 2.39%, reflecting broad profit-taking across Asia after a strong year. Quarter-to-date performance remained modestly positive across most major regions, but dispersion widened as markets digested high valuations, concentrated leadership and shifting macro signals.

Despite just over 80% of S&P 500 companies beating expectations, US equities were broadly flat. The S&P 500 gained 0.25% and the Nasdaq recorded its first monthly decline since March, as strong earnings failed to assuage concerns around frothy valuations. Across the Atlantic, European equities outpaced the US, with the Eurostoxx 600 rising 1.04% in November. UK equities gained 0.4%, supported by softer inflation, which improved expectations for rate cuts in 2026.

In Japan, a weaker yen continued to support exporters, but tech-related softness contributed to a 5.41% decline in the Nikkei 225 after several months of strong performance. Elsewhere in Asia, markets retreated as investors locked in profits. Korea fell 3% in US-dollar terms, Taiwan declined 4%, and India slipped 0.2% - outperforming the broader region but still weighed down by global semiconductor weakness and caution around year-end positioning. China's CSI 300 Index declined 1.84%, with fragile domestic demand and property-sector uncertainty continuing to offset pockets of industrial improvement.

Emerging markets underperformed developed markets, dragged lower by technology-heavy economies in North Asia. Currency volatility and uneven macroeconomic data kept foreign inflows subdued, limiting the scope for a broader EM rally despite attractive relative valuations.

South African equities moved broadly in line with the global risk-off tone. The FTSE/JSE All Share Index tracked softer commodity markets, with resources under pressure amid weakening industrial metal prices, while gold pulled back from recent highs but remained resilient on ongoing uncertainty and future rate-cut expectations. Domestic sentiment remained anchored by stable monetary policy expectations and fiscal consolidation, while the rand stayed range-bound but sensitive to shifts in global rate expectations and broader EM risk appetite.

The top contributors to the Fund's performance for the month were Anglogold Ashanti Plc (21.63%), China Construction Bank Corp (6.10%) and Reliance Industries Ltd (5.46%). Detractors included Taiwan Semiconductor Manufacturing (-4.00%), Alibaba Group Holding Ltd (-8.24%) and Samsung Electronics Co Ltd (-5.76%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.
