



#### **FUND COMMENTARY**

Aided by recovering sentiment and moderating recession fears following April's trade tension fireworks, global equity markets broadly continued with their impressive rebound in May. The MSCI World Index advanced 5.92% during the month, firmly getting back into positive territory for the 2025 year so far at 4.95%.

In the US, the S&P 500 Index was among the top performing broad market indices, gaining 6.29% for the month. This was supported economic resilience, as demonstrated by a strong quarterly earnings reporting season.

European markets also posted solid gains, with the Eurostoxx 600 index closing the month 5.60% higher. Regional sentiment remains elevated, driven by expectations of softer interest rates and a more expansionary fiscal outlook. Further east, Japan's Nikkei 225 index ended the month 4.43% higher in hard currency terms, as the Yen cooled against the US Dollar.

Emerging Markets also advanced, with the MSCI EM Index rising 4.27%; however, they surrendered some of the relative gains made earlier this year versus developed markets. China, the largest single contributor to MSCI EM performance, posted only a modest gain, as the CSI 300 index rose 2.87% in US dollars.

Domestically, the local equity market reached new all-time highs, as the FTSE/JSE All Share Index rose 3.14% for the month. The market has now delivered a remarkable 14.02% return year-to-date and 25.54% over the past 12 months. All three broad market sectors contributed positively, with Industrials leading at 5.86% and Resources and Financials following closely behind at 2.65% and 2.47% respectively.

The top contributors to the Fund's performance for the month were Naspers (+5.6%), Sibanye (+27.5%), and Prosus (+6.3%). Detractors included Harmony Gold (-13.2%), Gold Fields (\*\*-3.3%), and Nepi Rockcastle (-3.0%).

#### **GLOSSARY**

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.
