



FUND COMMENTARY

Risk sentiment towards SA has improved somewhat. Bond prices have gradually strengthened again since April, as the angst over America's anti-SA rhetoric and tariff threats has subsided and the GNU is somehow keeping it together. After breaking 11% post Liberation Day, the 10-year yield is back below 10%. It eased a further 20bp in June.

Inflation appears to have settled near the bottom end of the target range while the rise in precious metal prices should benefit the fiscus by way of higher tax revenues and help stabilise our debt-to-GDP ratio (which, compared to the US, suddenly looks quite reasonable). The yield spread to US 10year Treasuries has narrowed by 60bp over the past two months.

General Information

Collective Investment Schemes in Securities (CIS) should be considered as medium to long-term investments. Forward pricing is used. Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest-bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

Total Expense Ratio (TER)

The Fund's **Total Expense Ratio (TER)** reflects the percentage of the average **Net Asset Value (NAV)** of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC)

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TFR.

Total Investment Charge (TIC)

The sum of the TER and TC. The accurate figures will be available a year after the fund's inception date.

Glossary Summary

Performance: Performance has been calculated using NAV to NAV with income reinvested.

Conservative: These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely.

Fund Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives Risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest Rate Risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Derivative counterparty risk: A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.

Liquidity risk: If there are insufficient buyers or sellers of particular investments, the result may lead to delays in trading and being able to make settlements, and/or large fluctuations in value. This may lead to larger financial losses than expected.
