Investment and Return Objective

The investment objective of the Fund is to provide an attractive total return to investors, applying a conservative income focussed investment style and targeting capital preservation.

Investment Process

To achieve this objective, the fund will be investing primarily through global collective investment schemes (and / or directly) in a diversified portfolio of predominantly defensive assets, such as government fixed income securities and investment grade corporate fixed income securities. The fund will also allocate limited exposure to growth assets such as equities, high yield fixed income securities, emerging market fixed income securities as well as real assets. The Fund may use financial derivative instruments for efficient portfolio management purposes and hedging.

There is no geographic or sectoral bias intended and the Fund will have exposure to both developed and emerging markets.

Suitable Investors

The Fund is suitable for investors who have a low to medium risk profile and who wish to capture upside attractive total returns from income producing assets while minimising downside volatility over the medium to long term.

FUND COMMENTARY

The quarter delivered gloomy performance, with both developed and emerging market equities selling off after spectacular 12 month returns. Long bonds sold off and credit spreads expanded in most regions except European Corporate High Yield bonds. Commodities were supported by energy, notably crude oil. Metals and agriculture were mostly down with some exceptions such as sugar, aluminium and iron ore.

Across the globe, the macro environment has been driven by expectations of tight monetary policy for longer, and limited support from a Chinese economic recovery. The US has maintained strong economic growth in Q3 2023, supported by a tight labour market and a not often spoken of Government consumption, thus fiscal stimulus. US growth continues to surprise on the upside, but beware, the labour market is showing signs of normalisation, wage pressure is slowing among the indicators. The services side of the US is also growing at a much slower pace and will probably follow the goods sector to very slow or negative growth in 2024. The EU is flat lining, with little or no growth prospects. Global growth will be challenging over the next year.

The rolling over of the growth cycle is fuelling asset volatility, and the potential secular changes over the next decade is adding to the risk. Fund positioning is very conservative, given the macro environment expected over the next year, notably decelerating growth. Risk allocation is very low and asset allocation has a strong bias to defensive assets and a low exposure to growth assets.





Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating positive returns and is generally calculated as percentage of investment profits, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Fund Specific Risk
