



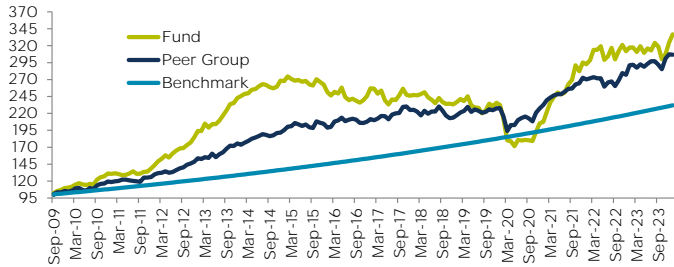
FUND OBJECTIVE & STRATEGY

The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

WHO SHOULD INVEST

MONTHLY COMMENTARY

The ClucasGray Future Titans Prescient Fund was up 3.7% in a very difficult month where the flexible index was down 0.2%. Expectations for US interest rate cuts were tempered in January with strong data showing rates in the US will only likely be cut in Q2. The JSE in particular had a difficult month with commodities counters selling off and the significant pullback in China not helping. Future Titans had a significantly better month helped by the move of Shoprite from the Zambian register, where they were valued at R64, to the South African register. Whilst sounding simple, this was the first movement of shares from Zambia to South Africa and required Shoprite board approval, SARB approval and ZSE approval and involved a host of administrative people to get the process done. It has taken many years but we eventually unlocked significant value, which talks to our philosophy of activism and a private equity mindset for longer term investments.

Capital Appreciation hosted a payments investor day to highlight the significant growth and changes coming in POS (point of sale). South Africa currently has 870,000 POS terminals of which Capital Appreciation (JSE code CTA) current has 344,000, 70% of the 870k terminals operating are 2G and 3G technology which the government has legislated must be shut down - CTA's 1st growth area. Although 870k of terminals may seem significant in SA it is estimated 65 to 70% of all transactions are still cash based - the company's 2nd growth area. In addition, multi-lane checkouts at the likes of Checkers or Pick n Pay was the monopoly of Verifone as the integration e-socket excluded CTA from competing. CTA have now received global approval for their e-socket, providing a 3rd growth area. Lastly, MicroPOS technology is now available as an app on your phone - this is a huge global market where peers trade at big multiples. CTA supply this app which enables growth into the SME market - think the ice-cream salesman at the flea market on the weekends or the plumber - providing a 4th growth area for the company. CTA has 40c of the R1.20 share price as cash, pays a 7% dividend yield, is undertaking share buy backs and is just too cheap on a forecast 8.5x PE.

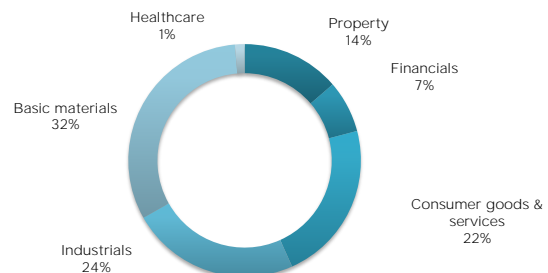
