The Fund's investment objective is to achieve long term capital growth by investing in global equity markets.

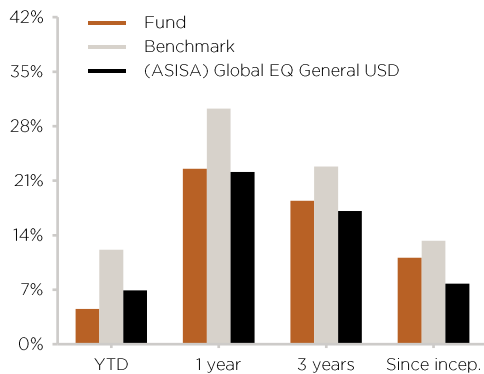
Risk Indicator Definition

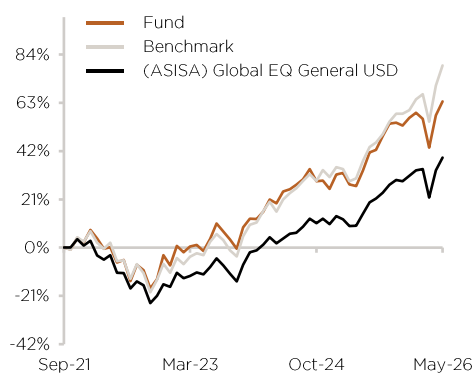


ANNUALISED PERFORMANCE (%)

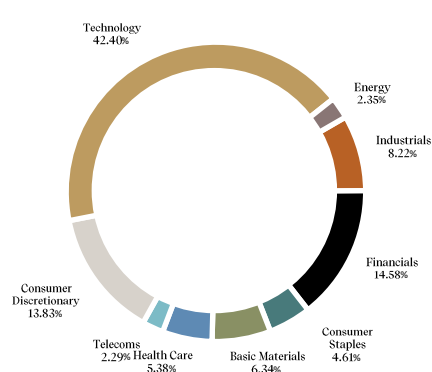

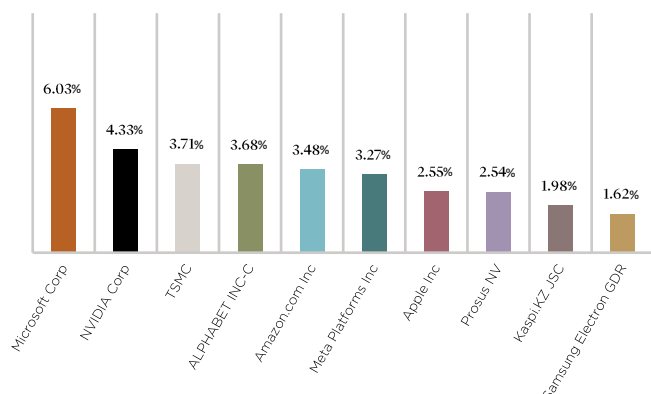

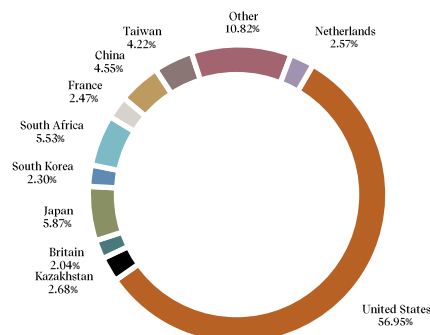
Income Distribution:

MARKET COMMENTARY

The fund returned 3.8% for the month, underperforming the benchmark by 1.37%. The MSCI ACWI Index gained 5.16%, with the Netherlands and the United States outperforming, rising 9.2% and 5.2% respectively, while China and the United Kingdom were the weakest, declining 3% and 0.3% (all figures in USD).

Global equity markets continued to recover in May, building on April's rebound as geopolitical risks eased and investor appetite for risk assets improved. US equities were particularly strong, with the S&P 500 up 5.3% and the Nasdaq 100 advancing 10.6%, supported by strength in technology and semiconductor stocks. The rally was driven by optimism around AI-related capital expenditure and earnings growth, with semiconductor-linked markets also performing strongly, particularly in Asia. Improved geopolitical sentiment also supported markets, as progress in US-Iran ceasefire negotiations helped reduce the risk premium that had built up in oil markets during March and April. Brent crude fell sharply as investors priced in a lower probability of broader regional escalation, although the improvement remains fragile, with security risks in the region continuing late in the month. Central bank policy also remained in focus. The macro backdrop remained mixed, with April payrolls rising by 115k and unemployment holding at 4.3%, while first quarter GDP growth was revised lower to 1.6%, pointing to an economy that remains resilient but is showing signs of moderating momentum.

European equity markets also advanced slightly in May, with the MSCI Europe Index rising 2.6%. Sentiment was supported by the broader risk-on environment and strength in AI and semiconductor-linked names. The Netherlands was a standout performer, rising 9.2% as ASML continued to benefit from strong investor appetite for AI infrastructure exposure. The economic backdrop remained mixed, with Eurozone inflation rising to 3.2% in May from 3.0% in April. The April ECB meeting kept rates unchanged, with expectations of a potential rate hike in June. Growth remained subdued, with Eurozone GDP and employment both rising by only 0.1% in the first quarter.

Emerging markets continued to deliver strong gains in May, with the MSCI Emerging Markets Index rising 9.7%, supported by the continued AI and semiconductor rally. Performance once again diverged meaningfully on a country level. South Korea and Taiwan were the standout performers, advancing 28% and 16.5% respectively, driven by strong demand for memory, foundry and semiconductor-related stocks as investor appetite for AI infrastructure exposure remained elevated. In South Korea, Samsung Electronics and SK Hynix continued to benefit from tight high bandwidth memory supply and strong AI-related demand, while Taiwan was supported by further gains in TSMC as demand for advanced chips and foundry capacity remained robust. By contrast, Indonesia fell 14.8% amid continued concerns around market accessibility, potential index-related outflows and foreign investor sentiment. Brazil also declined 9.1% as inflation concerns and restrictive monetary policy weighed on sentiment. Overall, May highlighted the extent to which AI and semiconductor exposure drove market leadership, while country specific macro and market structure concerns weighed on selected markets.

On a sector level, Information Technology was the best-performing sector over the month, where stock picking detracted from relative performance. The underweight to Health Care was the largest relative detractor, followed by stock picking in Consumer Discretionary. The fund's underweight to Utilities and Consumer Staples contributed positively to relative performance.

Notable portfolio actions during May included adding selectively to AI and semiconductor-related exposure. The fund increased its exposure to TSMC through both its US-listed ADR and Taiwan-listed ordinary shares. The fund also added to Salesforce and initiated a new position in Gold Fields. The fund fully exited Edenred, Richemont, Hacksaw and KDDI Corp. Overall, activity was focused on increasing exposure to high-conviction technology and AI beneficiaries, while reducing positions where the risk-reward or portfolio fit had become less compelling.

Notable contributors to fund performance were positions in Microsoft (+60bps absolute and +29bps relative), Dell (+52bps absolute and +45bps relative) and Samsung (+51bps absolute and +19bps relative). Notable detractors from performance over the month came from Zoetis (-29bps absolute and -27bps relative), Prosus (-15bps absolute and relative) and Sasol (-12bps absolute and relative). The fund is positioned with an underweight in cyclical names, in favour of technology exposure. From a geographical perspective, the fund remains underweight North America, while being overweight South Africa, Kazakhstan and China.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Performance Fee Cap: The maximum performance fee that can be charged over a specified period

Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
