

The annual fees include a fee of 0.10% paid to Prescient Management Company (RF) (Pty) Ltd. The Fund will invest in the International Flexible Fund where Kruger International Mauritius ("KIM") is the investment advisor. KIM may earn an annual investment advisory fee of up to 1.00% on this investment, but Kruger International does not charge an annual management fee against the value of the investments that are placed in the International Flexible Fund. These fees are stated exclusive of VAT. Please note that in most cases where the financial services provider (FSP) is a related party to the fund manager, the Description of the investment of the inv FSP/distributor may earn additional fees other than those charged by the fund manager.

Characteristics

This is a multi-asset income portfolio which means that it may invest in a spectrum of money market instruments, bonds, notes, debentures, preference shares as well as fixed income securities which are considered consistent with the portfolio's primary objective and that the Act may allow from time to time. The portfolio may, at the discretion of the portfolio manager, invest up to 45% of the assets outside of South Africa.

Risk Reward Profile: High

Typically, the lower the risk, the lower the potential return and the higher the risk, the higher the potential return. There is no guarantee that returns will be higher when investing in a fund with a higher risk profile. The risk profile for this fund is rated as high, as it may invest up to 100% in equity securities, both locally and abroad. The risk refers only to volatility

RISK DEFINITIONS

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The ers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss

Derivatives Risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Feeder Fund: A Feeder Fund is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund.

Collective Investment Schemes in Securities (CIS) should be considered as medium to long-term investments. The value may go up as well as down and past performance is not necessarily a guide to future performance. CIS's are traded at the ruling price and can engage in scrip lending and borrowing.
