

The fund will aim to provide medium to long-term capital growth with a targeted real return of 3%. The fund has a medium risk profile, and is suitable for long term investors seeking medium levels of investment growth, who can tolerate the associated medium levels of capital volatility.

The portfolio adhered to its investment objectives and there were no material changes to the composition of the portfolio, during the reporting period.

## Glossarv

- % POSITIVE MONTH: The percentage of months since inception where the Fund has delivered positive return.
- ALPHA: Denoted the outperformance of the fund over the benchmark
- ANNUALISED PERFORMANCE: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
- AVERAGE CREDIT QUALITY: The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).
- AVERAGE DURATION: The weighted average duration of all the underlying interest bearing instruments in the Fund.
- DIVIDEND YIELD: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

- HIGH WATER MARK: The highest level of performance achieved over a specific period.
- HIGHEST & LOWEST RETURN: The highest and lowest returns for any 1 year over the period since inception have been shown.
- MAX DRAWDOWN: The maximum peak to trough loss suffered by the Fund since inception.
- MAX GAIN: Largest increase in any single month.
- NAV: The net asset value represents the assets of a Fund less its liabilities.
- PERATIO: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.
- SHARPE RATIO: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
- STANDARD DEVIATION: The deviation of the return stream relative to its own average
