Fund Objective

The objective of the Fund is to track the performance of global emerging market equities.

Investment Strategy

The State Street Global Emerging Markets Screened Index Equity Fund ("Fund") is an index fund tracking the performance of the MSCI Emerging Markets Screened Choice Index ("Index"). The environmental and social characteristics are promoted by a negative and normsbased screen applied to the Index designated by the Fund to screen out securities based on an assessment of their adherence to ESG criteria. The Index represents the performance of the broad global emerging equity markets while excluding companies that are associated with controversial weapons, nuclear weapons, civilian firearms, fossil fuel extraction, thermal coal power and tobacco or fail to comply with United Nations Global Compact ("UNGC") principles.



Why is the Fund in this category? The Fund is in risk category 6 as its return has experienced very high rises and falls historically.

Index Tracking Risk: The Fund's return may not match the return of the Index. The Fund's ability to track the Index will be affected by Fund expenses, the amount of cash and cash equivalents held in its portfolio, and the frequency and the timing of purchases and sales of interests in the Fund. The Investment Manager may attempt to replicate the Index return by investing in a sub-set of the securities in the Index, or in some securities not included in the Index, potentially increasing the risk of divergence between the Fund's return and that of the Index
