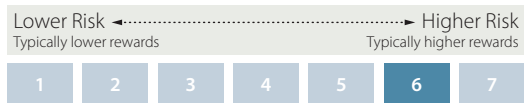

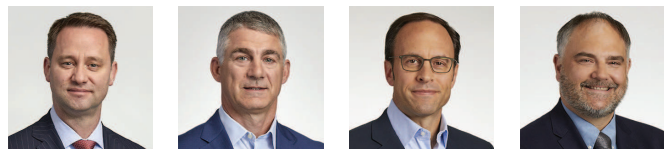

Glossary Summary
