The Fund aims to achieve long term capital growth appreciation over a full market cycle by maintaining meaningful exposure to growth assets like equities.


#### **INVESTMENT POLICY**

#### **ANNUALIZED PERFORMANCE (%)**





#### **CUMMULATIVE PERFORMANCE**





### **FUND COMMENTARY**

Wall Street equities recorded their weakest quarterly performance in nearly three years, amid mounting concerns that President Donald Trump's proposed tariffs may herald a period of stagflation in the United States. The S&P 500 declined by 4.6%, marking its most significant drop since the third quarter of 2022. The downturn intensified in March, as investors positioned themselves ahead of "Liberation Day" on 2 April, when a broad set of additional tariffs is scheduled to take effect. In contrast, European equity markets outperformed both over the quarter and in March, as did most Asian markets—with the notable exception of Japan. Thus far, the economic landscape under the Trump administration has not met expectations. Initial optimism that his policy agenda would support U.S. equities and strengthen the dollar has faded. Instead, growing concern over the potential economic fallout from proposed tariffs has unsettled investors. All three major U.S. stock indices are in negative territory for 2025, Treasury yields have declined to five-month lows despite rising inflation expectations, and key economic indicators suggest a slowdown in growth. Meanwhile, the dollar is weakening, credit spreads in the high-yield corporate bond market are widening, and a clear shift in sentiment is evident as investors reduce exposure to U.S. assets in favour of a more risk-averse positioning.

#### **Risk Indicator Definition**

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product.
