QUARTERLY COMMENTARY | JUNE 2025

The ClucasGray Global Fund rose 3.1% in June and 7.4% for the second quarter, while the Morningstar Aggressive Allocation peer group gained 2.9% and 7.1%, respectively. Global equities hit new all-time highs last month, recovering from the sharp tariff induced sell-off at the start of the quarter. The MSCI All Country World Index rose 4.4% in June and 11.0% for the quarter.

Dramatic shifts in US trade policy drove wild price swings in the second quarter. The Trump administration's sweeping tariff announcements at the start of April weighed heavily on global equities with the MSCI ACWI tumbling -10.1% in the days that followed. The implementation of higher tariff rates was subsequently paused and tensions further de-escalated throughout the quarter as global trading partners entered into trade negotiations with the US, leading to a 21.8% market recovery from the April low to the end of June.

After a weak first quarter, US markets led on the upside in the second quarter, with the S&P 500 gaining 10.6% and the technology-heavy Nasdaq index rebounding 17.7%. US market performance, however, continues to materially lag that of its European counterparts, which have benefited from elevated US policy uncertainty. Investors have aggressively shifted allocations to the relative certainty of European markets, while a notable weakening of the US dollar (-10.7% year to date) has boosted USD returns in the region.

Positive contributions to Fund's second quarter performance came primarily from technology companies, with the sector rebounding from a sharp drawdown at the start of the year. Nvidia (+45.8%) led on the upside in Q2, followed by TSMC (+36.4%) and Microsoft (+32.5%). Accounting and tax software provider Intuit (+28.3%) also jumped after reporting robust results and providing a confident outlook for the remainder of the year. Healthcare companies were the main detractors from quarterly performance, with United Health (-40.4%) selling off after warning that a material increase in medical claims rates will impact profitability. Life sciences giant, Thermo Fisher (-18.5%), also declined sharply amid tariff headwinds and reduced government research funding.

During the quarter, the Fund adjusted its positioning for the uncertain market environment by reducing USD exposure and diversifying regionally through the addition of broad market ETFs covering Japan, Asia ex-Japan, and Europe. On an individual company basis, the Fund exited positions in Nike and Apple as both companies face significant potential tariff headwinds. The Fund initiated positions in EU-based consumer staple company Unilever, animal healthcare leader Zoetis, as well as a small position in online gambling solution provider Evolution AB.

At the end of June, the Fund had an underlying exposure to equities of 96.6%, and 3.4% cash.

The Fund has adhered to its investment policy.

The number of participatory units at 30 June 2025 was 441 278.






FUND ASSET ALLOCATION




NET CURRENCY EXPOSURE
