# MONTHLY COMMENTARY

Better than expected corporate earnings, the announcement of more trade deals and the passage of the One Big Beautiful Bill Act (OBBBA) by the US senate pushed global markets higher during the month with the MSCI All Country World Index adding +1.3%. Growth (+2.1%) outperformed value (+0.5%) driven by big tech and the ongoing demand for Al. Emerging markets (+2.0%) driven by China, outperformed developed markets (+1.3%) during July. The US consumer Price Index (CPI) came in better than expected, with core inflation surprising on the downside as the impact of tariffs remain limited thus far mainly due to good inventory management. This, together with uncertainty around the effect of tariffs on inflation for the remainder of the year and a US economy that remains resilient resulted in the US Fed holding rates steady. Eurozone bond yields moved higher as growth sentiment turned more positive. These factors negatively affected the World Government Bond Index (-1.8%) during the month.

The S&P 500 (+2.2%) and Nasdaq (+3.7%) moved higher during the month driven by stronger than expected corporate earnings, with the best performing sector within the S&P500, Information Technology adding +5.2% during July. The more value focussed Dow Jones Industrial Average ended the month flat. Annual inflation in the US accelerated for the second consecutive month to 2.7%, up from 2.4% in May. Core inflation went up to 2.9% from 2.8%, but below expectations of 3.0%. The increase could be the first sign of tariffs flowing through the economy and something that will be monitored closely in the months to come. The Federal Reserve held rates steady for a fifth straight meeting, but notably, two governors were in favour of a cut. The Fed noted that the unemployment rate remains low and while inflation remains somewhat elevated, uncertainty about the economy persists. Eurozone CPI held steady at 2.0%, unchanged from June but slightly higher than market expectations of 1.9%. Core inflation, which excludes energy, food, alcohol and tobacco also remained unchanged at 2.3%, its lowest level since 2022. The European Central Bank (ECB) kept rates unchanged during July, effectively marking the end of its current easing cycle after eight cuts over the past year that brought borrowing rates to their lowest levels since November 2022. ECB president, Christine Lagarde, said the central bank is in a good place but acknowledged the difficulty in assessing how tariffs will affect price outlooks, given the mix of both inflationary pressures. The EuroStoxx 50 (+0.4%), German DAX (+0.7%) and FTSE 100 (+4.3%) all moved higher during the month. Asian markets performed well with the MSCl Asia ex-Japan adding +2.6% amid an improving economic backdrop across the region and within China, recent activity indicators came in better than expected, most notably first half GDP growth of +5.3% and better than expected industrial production numbers helped the Shanghai Shenzhen add +3.7% during the month.

Our top performing shares during the month were Samsung Electronics, Evolution and Thermo Fisher with the biggest detractors being Novo Nordisk, UnitedHealth and Elevance.

## **DISCLAIMER**

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.
