

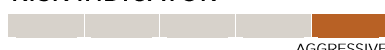
Investment Objective

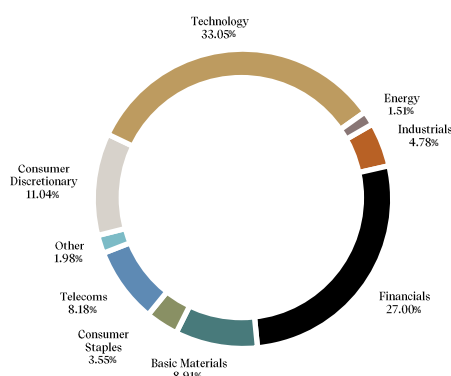

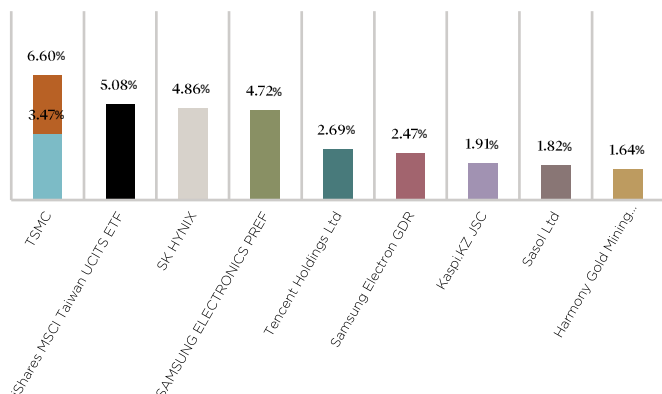

Income Distribution:

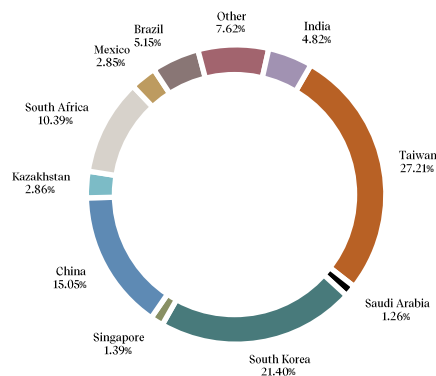

MARKET COMMENTARY

The MSCI Emerging Markets Index rose 9.69% over the month, while the MSCI ACWI Index gained 5.16%. Within emerging markets, South Korea and Taiwan were the standout performers, advancing 28% and 16.5% respectively. Indonesia and Brazil were the main detractors, declining 14.8% and 9.1% (all figures in USD).

Global equity markets continued to recover in May, building on April's rebound as geopolitical risks eased and investor appetite for risk assets improved. US equities were particularly strong, with the S&P 500 up 5.3% and the Nasdaq 100 advancing 10.6%, supported by strength in technology and semiconductor stocks. The rally was driven by optimism around AI-related capital expenditure and earnings growth, with semiconductor-linked markets also performing strongly, particularly in Asia. Improved geopolitical sentiment also supported markets, as progress in US-Iran ceasefire negotiations helped reduce the risk premium that had built up in oil markets during March and April. Brent crude fell sharply as investors priced in a lower probability of broader regional escalation, although the improvement remains fragile, with security risks in the region continuing late in the month. Central bank policy also remained in focus. The macro backdrop remained mixed, with April payrolls rising by 115k and unemployment holding at 4.3%, while first quarter GDP growth was revised lower to 1.6%, pointing to an economy that remains resilient but is showing signs of moderating momentum.

Emerging markets continued to deliver strong gains in May, with the MSCI Emerging Markets Index rising 9.7%, supported by the continued AI and semiconductor rally. Performance once again diverged meaningfully on a country level. South Korea and Taiwan were the standout performers, advancing 28% and 16.5% respectively, driven by strong demand for memory, foundry and semiconductor-related stocks as investor appetite for AI infrastructure exposure remained elevated. In South Korea, Samsung Electronics and SK Hynix continued to benefit from tight high bandwidth memory supply and strong AI-related demand, while Taiwan was supported by further gains in TSMC as demand for advanced chips and foundry capacity remained robust. By contrast, Indonesia fell 14.8% amid continued concerns around market accessibility, potential index-related outflows and foreign investor sentiment. Brazil also declined 9.1% as inflation concerns and restrictive monetary policy weighed on sentiment. Overall, May highlighted the extent to which AI and semiconductor exposure drove market leadership, while country specific macro and market structure concerns weighed on selected markets.

On a sector level, Information Technology was the best-performing sector and main contributor over the month, where the fund's substantial underweight detracted from relative performance. The fund's underweight to Energy and Utilities added to relative performance. The fund's overweight holdings in Consumer Discretionary and Financials detracted from relative performance.

On a country level, the portfolio's underweight to South Korea was the largest detractor from relative performance. Samsung and SK Hynix together account for approximately 70% of the MSCI Korea Index and over 15% of the MSCI EM Index. TSMC represents around 55% of the MSCI Taiwan Index and over 14% of the MSCI EM Index. The portfolio maintains a maximum regulatory position limit of 10% per stock, resulting in an unavoidable underweight. The continued strong performance in emerging markets was predominantly driven by these three names, namely Samsung, SK Hynix and TSMC, underscoring how concentrated the rally was in just a few stocks.

Notable portfolio actions during May included adding selectively in South Korea, where the fund added to SK Hynix, which continued to benefit from strong demand for high bandwidth memory, and initiated new positions in Kia Corp and Hyundai, broadening exposure to the Korean market. The fund also added to JD.com and initiated a new position in Gold Fields. The fund trimmed Kaspi and fully exited Bid Corp, Hindalco, Afya, Kingboard, Piraeus, Santam and BHP, reducing positions where the risk-reward or portfolio fit had become less compelling.

Notable contributors to fund performance were positions in SK Hynix (+382bps absolute and -249bps relative), Samsung (+173bps absolute and -95bps relative) and TSMC (+90bps absolute and -74bps relative). Notable detractors from performance over the month came from Futu Holdings (-27bps absolute and relative), Tencent (-23bps absolute and 2bps relative) and Sasol (-20bps absolute and -19bps relative).

The fund remains overweight South Africa and Kazakhstan, where we continue to identify compelling bottom-up opportunities. Conversely, the fund remains underweight India, China and South Korea, with India continuing to trade at elevated valuations relative to broader emerging market peers.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

High Water Mark: The highest level of performance achieved over a specified period.

Performance Fee Cap: The maximum performance fee that can be charged over a specified period

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
