INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve healthy real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - Low Equity funds over a full market cycle by maintaining moderate exposure to growth assets like equities.

INVESTMENT PROCESS

This Fund invests in local and offshore money market, bonds and inflation-linked bonds, property, preference and ordinary shares, derivatives and unlisted instruments to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation and exposure equities.

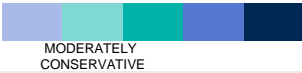
WHO SHOULD INVEST

Investors seeking real returns coupled with a stable and attractive income yield via significant exposure to the South African interest bearing markets. Although the Fund's mandate allows investment up to 40% in equities, it is expected to have lower actual exposure on average. This Fund is suitable to investors with a medium to long-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically have moderate equity exposure or in the case of bond funds, longer duration bond exposure, resulting in some capital volatility over the shorter term. They are managed in such a manner that the probability of capital losses over one year periods is unlikely. These portfolios typically target returns in the region of 3% - 4% above inflation over the long term.

FUND COMMENTARY

March saw further political pressure being imposed by the United States against its trading partners and the announcement by the US of a reciprocal tariff system against trading partners, such as the EU, which have high trade barriers in place with the US. While the stated aim of the tariff system is additional income and onshoring of jobs into the US, the short term effect is likely a partial increase in inflation as companies pass on the increased tariff costs directly to consumers, along with increases in market volatility.

Globally, China's central bank (PBOC) aims to maintain yuan stability and manage financial risks, particularly due to external tariffs. The PBOC's actions align with China's shift in monetary policy from "prudent" to "moderately loose" for 2025, focusing on stimulating consumption. The supportive monetary policy also aims to mitigate external pressures on exports, especially following the US decision to increase tariffs on Chinese goods by 20%. However at their first Quarterly meeting of 2025, China's central bank made the decision to hold benchmark lending rates steady for the fifth straight month in March, matching market expectations.

The Bank of England also kept its key interest rate unchanged at 4.5% and emphasised the need for caution due to persistent inflation, while the European Central Bank (ECB) decided to cut key interest rates by 25 basis points from 2.75% to 2.5% at the March policy meeting. This was driven by weak economic prospects in the Eurozone and the ongoing disinflationary trend.

The postponed national budget has finally taken place with the key themes being around the proposed VAT increase, additional allocation to public sector wages, and projected economic impacts including reduced budget deficits and continued social grants. Finance Minister Enoch Godongwana tabled a proposal to increase South Africa's VAT rate by 0.5 percentage points in 2025/26 and by a further 0.5 percentage points in 2026/27. The move is likely to spark a showdown in parliament between the ANC and DA – the two main parties in the GNU. The DA has been vocal about their opposition against a VAT hike as well as other major tax increases such as a wealth tax, rather favouring spending cuts.

In March, the MSCI World Index fell by -4.64%, while its emerging market counterpart managed a modest gain of 0.38%. Both the Nasdaq Composite and S&P500 Index continued their downward trend, posting monthly returns of -8.21% and -5.75%, respectively. The Chinese equity market showed some resilience, with the Shanghai SE Composite Index rising by +0.45% and the Hang Seng Composite Index gaining +1.22%. In the UK, the FTSE 100 Index ended the month down by -2.58%.

South Africa showed strong performance in both the equity and bond markets. The JSE TOP40 Total Return Index posted a solid gain of 4.06%, with only four companies detracting from its overall performance. The local bond market also saw positive results, as the JSE ALBI Index returned 0.19%.

The Fund currently holds a moderately negative view towards developed equity markets, a neutral stance on South African bonds and emerging market equity, and a moderately positive outlook on rand strength and South African equity.

The Fund was marginally negative for the month, with positive performance from SA equity being offset by poor global equity performance.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
