The objective of this fund is to generate long-term capital growth and outperform the benchmark over a rolling five year period. The fund will have exposure to a broad range of markets across multiple asset classes, including both local and offshore investments. Underlying investments may include both actively managed and index-tracking strategies. The strategy is constructed with a medium allocation to equity.

The fund has adhered to its policy objectives as stated in the supplemental deed.

This fund is suitable for investors who seek income and capital growth in the long term and an investment diversified across multiple asset classes. These investors are willing to withstand moderate levels of short-term market volatility.



Portfolio composition

The Cogence Balanced Prescient Fund of Funds is constructed as a diversified portfolio of funds spanning various asset classes, and across both active and passive strategies. Asset allocation and global manager selection advice is provided by BlackRock, while RisCura provide local manager selection.

During the first quarter of 2025, the portfolio's offshore (global ex-SA) allocation increased by 2.30% to 38.30%. SA cash and SA equity reference allocations were reduced by 3.10% and 0.20%, respectively, and redeployed into SA bonds which has a 1.00% underweight. The local and global managers remained unchanged.

The portfolio remains within the defined risk parameters of a high risk profile as per the ASISA category's maximum equity allowance of up to 75%.

Monthly market commentary

Global equities rebounded sharply in May, with the MSCI World Index up (2.80%). The rally was led by a resurgence in US markets, underpinned by resilient economic data, slowing inflation, and improved trade sentiment. A 90-day pause on proposed US tariffs against China, alongside a moderate trade deal with the UK, helped ease fears of an escalating trade war. This moderation in geopolitical risks, coupled with strong earnings from Nvidia, reignited investor enthusiasm for AI and bolstered the broader technology sector.

Developed market (DM) equities outperformed, led by the US with the S&P 500 up 3.12%, followed by the MSCI UK (+1.96%) and Europe ex-UK (+1.51%). Emerging market equities rose more modestly (1.19%) but remained ahead of DM peers year-to-date, aided by a weaker US dollar and positive performance from China, South Africa, and Mexico. In contrast, Brazil and India underperformed.

Global bond markets had a challenging month with the Bloomberg Global Aggregate Bond Index down 0.33%. Yields spiked amid concerns over US fiscal sustainability, following Moody's downgrade of US sovereign debt. Long-end yields also moved sharply higher in the UK and Japan. Elsewhere, gold paused after a strong multi-year run, and oil prices remained relatively stable despite OPEC+ announcing a third consecutive production increase.

South African (SA) financial markets continued their recovery. President Ramaphosa's visit to the White House helped restore confidence in US-SA relations and while loadshedding remained a challenge, its lower intensity and a renewed focus on water infrastructure helped reduce domestic uncertainty. The FTSE/JSE All Share Index was up 3.14%, supported by a broad-based rally across sectors: industrials (+3.98%), resources (+2.30%), and financials (+2.09%), and the All-Property Index rose 3.15%.

SA bond markets were supported by falling yields, lifting the All Bond Index by 2.73%. The SARB cut its repo rate by 25bps to 7.25%, reflecting a softer inflation backdrop. Inflation-linked bonds gained modestly (+0.45%), and cash (STeFI) returned 0.61%. Currency markets also responded positively. The rand appreciated by 3.3 % against the US dollar, making it one of the best-performing major currencies.

Yields

The yield for bond and income portfolios is historic and is calculated quarterly.

Important information

The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. Lump-sum performance returns are being quoted. Income distributions, prior to deduction of applicable taxes, are included in the performance calculations. NAV to NAV figures have been used for the performance calculations, as calculated by the manager at the valuation time of 16:00 as defined in the deed, over all reporting periods. Investment performance calculated on the actual amount distributed per participatory interest, using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. The performance is calculated for the fee class. Glossary

Annualised return - An annualised return is the weighted average compound growth rate over the period measured.

Highest & Lowest return - The highest and lowest returns for any one year over the period since inception have been shown.

Volatility - Volatility (also called standard deviation) is a measure of how widely the returns varied over the period measured.

Maximum drawdown - A maximum drawdown is the maximum loss from a peak to trough of the portfolio over the period measured, before a new peak is attained.

Sharpe ratio - The sharpe ratio is a measure of risk-adjusted returns. The sharpe ratio reflectes the extent to which an investment compensates for extra risk.

NAV - The net asset value represents the assets of a fund less its liabilities.

What is the total investment charge (TIC)

Total expense ratio (TER) is the percentage of the value of the portfolio that was incurred as expenses relating to the administration (charges, levies and fees) of the portfolio. TER is calculated over rolling 3 years (or since inception, where applicable), and is annualised, to the most recent calendar quarter-end. A higher TER does not necessarily imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs (TC) is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction Costs are a necessary cost in administering the portfolio and impacts portfolio returns. It should not be considered in isolation, as returns, may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the TER. Calculations are based on actual data, where possible, and best estimates, where actual data is not available. Total investment charges (TIC) is the percentage of the value of the portfolio that was incurred as costs relating to the TER and TC.
