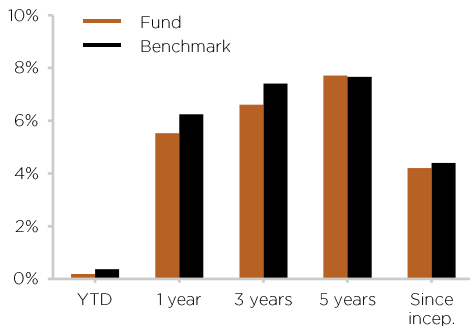
Risk Indicator Definition

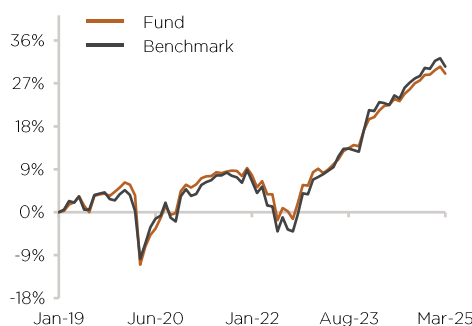
RISK INDICATOR

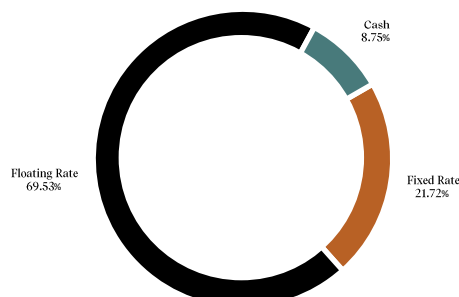

MARKET COMMENTARY

Market dynamics:

European credit markets wilted during March, with the credit benchmark iTraxx XOver 5-year Spread Index increasing by around 41 basis points (bps) to end the month at 330 bps. The underlying sell-off does mask the launch of the new Series 43 on the 20th, which extended the tenor and risk profile of the on-the-run issue, adding around 10 bps. Bearing this in mind, the real sell-off could be argued to have only been 31 bps. Nonetheless, the extent of the sell-off was rather sharp and largely unexpected. To put things in a relative setting, one must go back to September 2022 to find a sell-off that was bigger in absolute magnitude than what was witnessed during March. The backdrop was poor, with risk sentiment changing as markets began discounting the effects of the impending and probable "Tariff Wars" due to commence in early April.

Overall, the iTraxx 5-year XOver Total Return Index lost some 1.30%, which has basically erased its heretofore 2025 healthy gains. The index has pared back its year-to-date performance to a meagre 0.37%.

March remained default-free, according to Markit, with no recovery auctions taking place or scheduled in the near term. There have been no meaningful defaults in 2025, with the last major default occurring in November last year.

The Fund (A class) lost some 1.12% after fees, generating a negative return outright but outperforming the benchmark by around 0.18%. The Fund is currently up some 0.18% on a year-to-date basis but remains a few bps behind the benchmark during calendar 2025.

We intend to deploy further capital to work into any sell-off in the market during April.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

High Water Mark: The highest level of performance achieved over a specified period.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
