



FUND COMMENTARY

Looking at South African asset classes for the quarter in rand terms, the Capped SWIX returned 5.8%, while SA Property was down 4.2%, and
the All Bond Index rose by 0.7%. Across offshore asset classes in US dollar terms, the MSCI All Country World Index declined by 1.2%, Offshore
Property delivered 1.9% and Offshore Bonds returned a positive 0.6%. The rand strengthened over the period, appreciating by 2% against the
US dollar. The quarter closed with the USD/ZAR exchange rate at R18.32.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any I year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.
