INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - Low Equity funds over a full market cycle by maintaining a meaningful exposure to a broad range of asset classes.

INVESTMENT PROCESS

The Fund invests across a range of asset classes, both domestically and offshore. The asset allocation is with reference to the long-term strategic allocation, but with tactical asset allocation views overlayed in order to capitalise on market opportunities and for risk management. The portfolio comprises best-of-breed asset class specialist funds as well as asset class replication to reduce costs.

WHO SHOULD INVEST

Investors seeking real returns over the long term and who want to diversify and reduce their risk of being exposed to a single asset manager. The Fund is suitable for investors with a medium to long-term investment horizon and is Regulation 28 compliant.

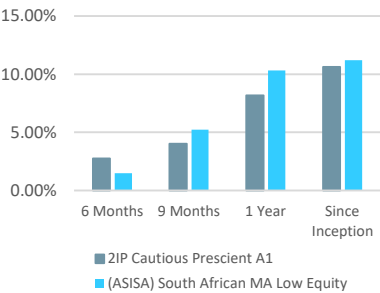
RISK INDICATOR DEFINITION

RISK INDICATOR



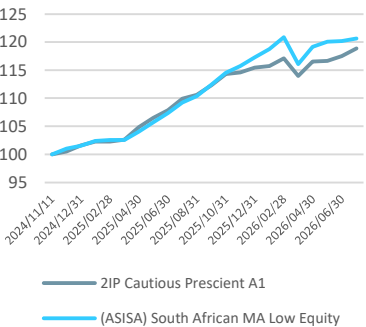
ANNUALISED PERFORMANCE (%)



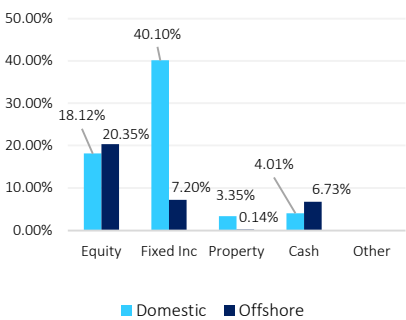

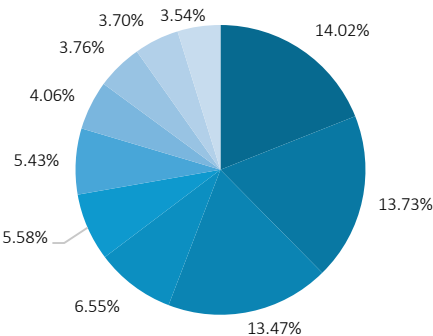
ILLUSTRATIVE PERFORMANCE (%)

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

FUND SPECIFIC RISKS

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

The portfolio has adhered to its policy objective and there were no material changes to the composition of the portfolio during the quarter.

QUARTERLY FUND COMMENTARY

Global financial markets delivered a strong second quarter despite heightened geopolitical tensions and periods of elevated volatility. The conflict in the Middle East initially disrupted energy markets and drove oil prices sharply higher, but sentiment improved meaningfully after a ceasefire agreement and the reopening of the Strait of Hormuz eased concerns over global energy supply. Brent crude oil retreated significantly by quarter-end, helping reduce inflationary pressures and supporting broader market confidence. Global equities recorded their strongest quarterly performance since 2020, underpinned by resilient corporate earnings, robust economic data and continued investment in artificial intelligence (AI) infrastructure. While AI remained a key driver of returns, investor leadership broadened beyond the largest technology companies, with memory chip manufacturers and Asian semiconductor firms benefiting from expanding capital expenditure. Emerging markets outperformed developed markets, led by South Korea and Taiwan, whose semiconductor industries continued to benefit from strong AI-related demand. In contrast, Chinese equities remained volatile as weak consumer spending and subdued economic growth offset improving manufacturing activity. US monetary policy remained cautious, with the Federal Reserve maintaining interest rates while signalling a greater willingness to keep policy restrictive should inflation remain elevated. South African markets experienced a more challenging quarter. Resource shares came under considerable pressure as gold and platinum prices retreated from earlier highs, weighing heavily on the JSE. In contrast, domestically focused sectors proved more resilient. Financial shares delivered solid gains, supported by improving economic activity, while selected retailers recovered as company earnings demonstrated resilience despite difficult trading conditions. Inflation accelerated during the quarter as higher fuel prices filtered through to consumer prices, prompting the South African Reserve Bank to raise the repo rate by 25 basis points. However, easing oil prices toward quarter-end improved the inflation outlook, while government bond yields declined as investors anticipated more stable price pressures. South Africa's first-quarter economic growth exceeded expectations and sovereign credit rating upgrades from Moody's and Fitch provided additional support for investor sentiment. Although the rand weakened during periods of global uncertainty, it recovered much of its losses as commodity markets stabilised. Looking ahead, the trajectory of inflation and the South African Reserve Bank's policy response will remain key determinants of domestic market performance, while globally investors continue to monitor the sustainability of AI-driven earnings growth and evolving geopolitical risks.
