

# PRESCIENT MONEY MARKET FUND (A2)

## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve returns above the STeFI Call Index, while minimising the risk of any underperformance. Importantly, the Fund is managed conservatively and it aims to maintain capital stability and liquidity.

### INVESTMENT PROCESS

The Fund invests in cash and high-quality capital market instruments. The Fund is structured to minimise the risk of not meeting the benchmark. Returns achieved above the benchmark are used in specialist strategies designed to enhance yield further.

### WHO SHOULD INVEST

Investors seeking a liquid, low risk money market offering, with enhanced yields. This Fund is suitable to investors with a short-term investment horizon and is Regulation 28 compliant.

### RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

## FUND COMMENTARY

July saw the positive momentum gained during the past couple of months continue, with another strong month for South African Fixed Income markets. The South African yield curve bull flattened during the month. A key driver is the SARB’s more enhanced focus on a point target of 3% for inflation compared to the current midpoint target of 4.5%.

In July, the Federal Open Market Committee (FOMC) opted to keep the federal funds’ rate unchanged. Chair Powell acknowledged the softer pace of growth in the first half of the year, noting that while the labour market remains solid, it faces downside risks—a point he emphasized six times during the briefing. He also stated that inflation is nearly way back to the 2% target.

Locally, the South African Reserve Bank (SARB) cut the repo rate by 25 basis points, in line with market consensus. The decision was unanimous among Monetary Policy Committee (MPC) members. More notably, SARB Governor Lesetja Kganyago announced a significant shift in the Bank’s inflation-targeting approach. While the official target range of 3% - 6% remains unchanged for now, the Bank will begin using the lower end of the range, 3%, as the point estimate in its Quarterly Projection Model (QPM). This lower anchor will remain a technical adjustment until formal adoption through the legislative process.

The 12-month NCD rate remains fairly steady with a small rally of 0.5 basis points, as the 3-month JIBAR declined by 25 basis points over the month in line with the repurchase rate cut of 25 basis points.

South African Treasury Bills are still favourable, currently offering better pickup over the 6, 9 and 12-month tenors over NCD.

We still favour Treasury bills when investing in fixed assets rather than Bank NCDs and continue to add credit conservatively when available in the primary or secondary market.

All asset classes contributed positively towards the month’s performance, both the fixed rate exposure and high-quality floating rate corporate assets adding to our above benchmark return.

The Fund delivered strong performance in July, bolstered by positively yielding assets, which contributed meaningfully to the overall return.

There were no detractors over the month.

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
