

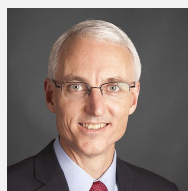

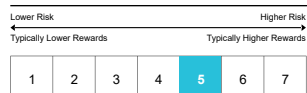

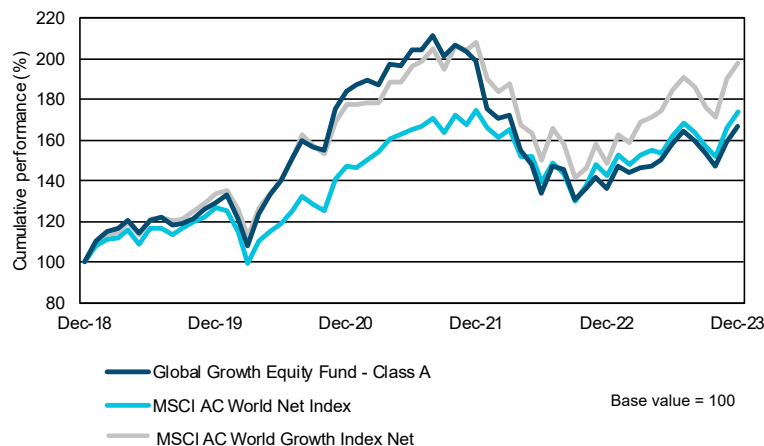
INVESTMENT PROCESS
