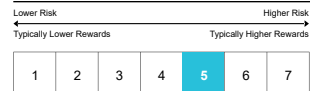

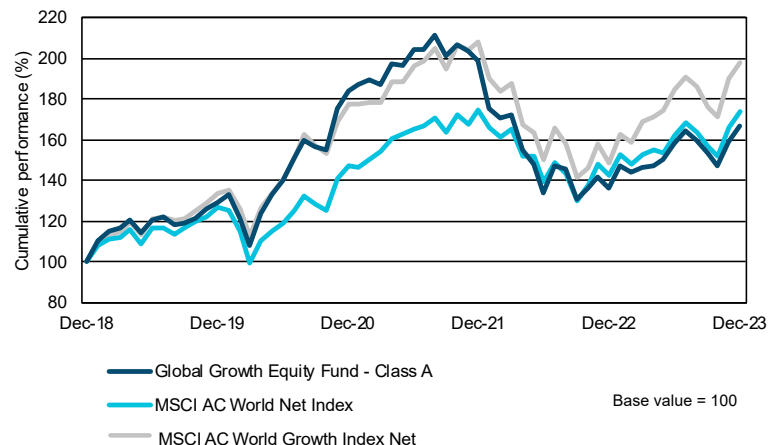
INVESTMENT PROCESS
