INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return CPI + 3% per annum through a full interest rate cycle while providing stability by aiming never to lose capital over any rolling 3 month period.

INVESTMENT PROCESS

This Fund invests in local money market, bonds, inflation-linked bonds, preference shares and derivatives to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes and also via the use of derivatives.

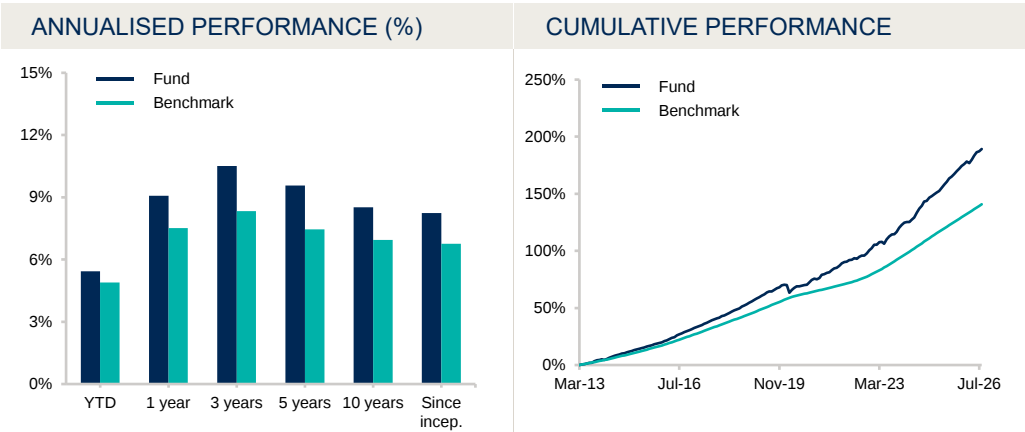
WHO SHOULD INVEST

Investors seeking stable real returns and aiming to maximise income via exposure to primarily the South African Money and Bond markets. This Fund is suitable to investors with a short- to medium-term investment horizon and is Regulation 28 compliant.

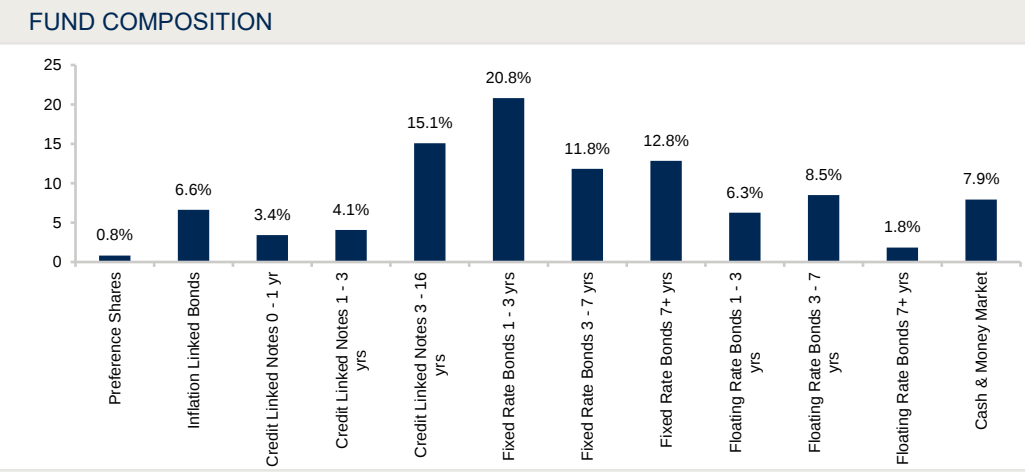
RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. FUND COMMENTARY

August brought welcome disinflation at home even as the external backdrop stayed tense. July CPI, released on 20 August, slowed to 4.3% from 5.0% as June's fuel spike unwound (petrol -7.1% and diesel -11.7% on the month, cutting annual fuel inflation to 20.6% from 34.3%) and food inflation fell to just 0.9%, its lowest in more than sixteen years; softer municipal tariff increases added to the relief. The reprieve came against still-elevated energy, however: with the US-Iran standoff over the Strait of Hormuz unresolved and sanctions on Iranian crude in place, Brent rose above \$90 from an intramonth low of just \$80 through the month, even as rising Gulf flows and a tentative Iran-Oman corridor framework late in August capped further gains.

Domestic assets opened the month firmly. The rand ranked among the strongest emerging-market currencies pulling the 10-year yield toward 8.5% and the rand to roughly R16.15 by month-end. The move partly reversed into the close as sticky oil and a hawkish Fed lifted the 10-year back toward 8.7%. With no MPC meeting in August, the repo rate held at 7.00% ahead of the September decision; offshore, Fed Chair Warsh used Jackson Hole to reaffirm a "firm, fixed" 2% inflation target and the US 10-year rose to 4.73%.

The Fund closed August with a gross yield of 9.07% and a modified duration of around 2.14 years, its carry from money market and floating-rate exposure again underpinning returns while a measured duration stance navigated the round-trip in yields. Positioning stays balanced: the domestic inflation picture has clearly improved, but oil near \$90 and a hawkish global rates backdrop argue against adding duration aggressively. The Fund retains flexibility to extend should disinflation broaden and the SARB signal easing, while holding carry as the ballast.

The Fund delivered a positive return in Aug that was better than its benchmark. The yield base added most for the month as did the fixed rates at the front end of the curve. The biggest detractor being the backend Fixed Rate Bonds in the portfolio.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
