ABOUT THE FUND

The Fund is actively managed on a discretionary basis to provide stable long-term growth with moderate level of risk. The Fund shall be within 2 years of the modified duration of the BEASSA Total Return Index.

INVESTMENT STRATEGY

The Fund aims to deliver a return in excess of the benchmark over the long term, which comprises a reasonable level of income, as well as capital performance relative to the benchmark. The portfolio will invest in interest bearing and non-equity securities (including, but not limited to, government or quasigovernment bonds, corporate bonds, cash deposits, money market and other interest-bearing securities), as well as listed and unlisted financial instruments in line with appropriate regulations. The investments are actively managed and will change over time to reflect a macro fundamental outlook including the interest rate cycle, business cycle, default cycle, as well as other cyclical and credit factors.

The portfolio has adhered to its investment objective and there were no material changes to the composition of the portfolio during the reporting period.





FUND COMMENTARY

The South Africa sovereign yield curve bull flattened, with the long end leading the rally. US–South Africa diplomatic tensions persists. However, market sentiment improved after the 90-day suspension of US reciprocal tariffs. Still, global trade uncertainty and domestic logistical bottlenecks remained top concerns. Locally, markets welcomed clarity that a VAT hike was off the table, and political uncertainty around the GNU eased through May, though reforms have yet to materialise.

A sharp drop in US bond yields following some weak U.S. economic data, and a clear market response to a parliamentary committee formally backing the National Treasury's fiscal framework, sent SA bond yields sharply lower.

Also worth noting is that the overall strong performance for SAGBs was also driven by a well-telegraphed and dovish policy pivot. In our views, SAGBs are still discounting a marginal domestic risk premium, which we expect to compress in due course. Inflows into SA bonds will most likely support the ZAR to establish a virtuous cycle.

GLOSSARY

- Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
- Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.
- NAV: The net asset value represents the assets of a Fund less its liabilities.
- Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
- Standard Deviation: The deviation of the return stream relative to its own average.
- Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.
- Max Gain: Largest increase in any single month
- % Positive Month: The percentage of months since inception where the Fund has delivered positive return.
- · Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.
- · Average Credit quality: The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).
