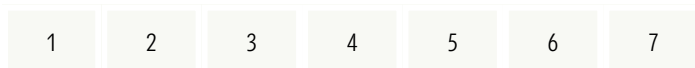
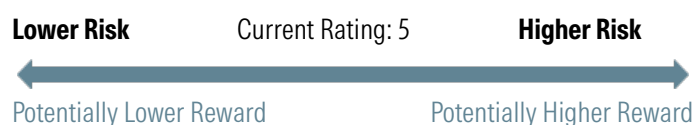

Authorisation of GQG Global UCITS ICAV by the CBI is not an endorsement or guarantee by the CBI nor is the CBI responsible for the contents of any marketing material or the Fund's Prospectus, Supplement or applicable Key Information Document ("KID") (or Key Investor Information Document ("KIID") for the United Kingdom).
