The Fund invests in cash and high-quality capital market instruments. The Fund is structured to minimise the risk of not meeting the benchmark. Returns achieved above the benchmark are used in specialist strategies designed to enhance yield further.

#### WHO SHOULD INVEST

Investors seeking a liquid, low risk money market offering, with enhanced yields. This Fund is suitable to investors with a short-term investment horizon and is Regulation 28 compliant.

#### **RISK INDICATOR DEFINITION**

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. 

#### **FUND COMMENTARY**

Locally, the Monetary Policy Committee (MPC) unanimously decided to cut the repo rate by 25 basis points. Since September 2024, the SARB has reduced rates by a cumulative 150 basis points. The near-term inflation outlook was revised lower, with the SARB now projecting headline inflation to average 3.3% in 2025 and 3.5% in 2026. The lower policy rate reflects more accommodative monetary conditions, easing the cost of funds, which tends to push short-term yields down.

These rates indicate a relatively flat yield curve for short-term government debt, with Treasury bills continuing to offer a higher return than bank OTC paper.

The consistent demand for Treasury bills at auctions throughout the month as well as in the secondary market, points to healthy liquidity in these money market

The NCD rates for November 2025 came in around 15 basis points in 12-, 9- and 6-month tenors, and 2 basis points in the shorter 3-month area, while Treasury bills offered a better yield pickup around 18 basis points in the 9-month area over NCDs and 24.5 basis points in the 6-month area.

In a notable positive surprise for the market, S&P upgraded South Africa's sovereign credit rating from BB- to BB, citing an improving growth and fiscal trajectory, and maintained a positive outlook on the rating.

We still favour Treasury bills when investing in fixed assets rather than bank NCDs and continue to add credit conservatively when available in the primary or secondary market.

All asset classes contributed positively to the month's performance, with both the fixed rate exposure and high-quality floating rate corporate assets adding to our above benchmark return.

The Fund delivered strong performance in November, bolstered by positively yielding assets, which contributed a meaningful overall return for the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.
