The Fairtree Equity Prescient Fund is an actively managed general equity fund with a focus on maximizing total returns in excess of the benchmark, after fees, over the long term.

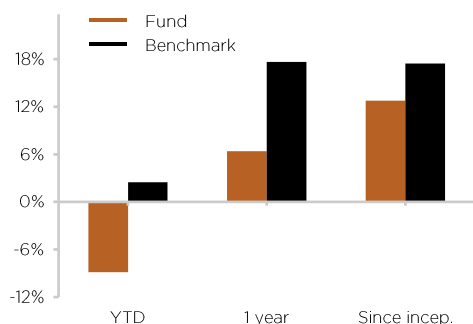
Investment Policy

The portfolio will aim to deliver long term capital growth by investing in both local and global equity markets. In order to achieve this objective, the portfolio will invest in selected shares across all industry sectors ranging across large, mid and smaller cap shares. The portfolio will seek to capture value by focusing on equity selection opportunities as well as quantitative screening process, based on various factors. The portfolio may include local, global developed and global emerging market equities. The portfolio will be exposed to exchange rate risk.

RISK INDICATOR

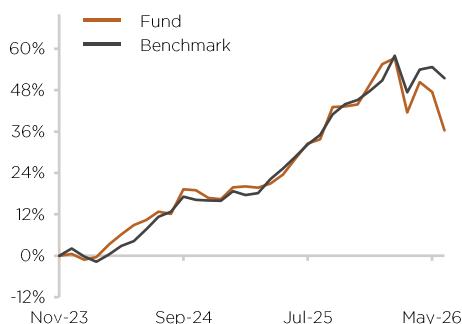


ANNUALISED PERFORMANCE (%)

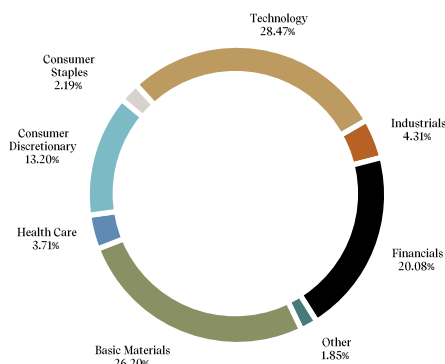

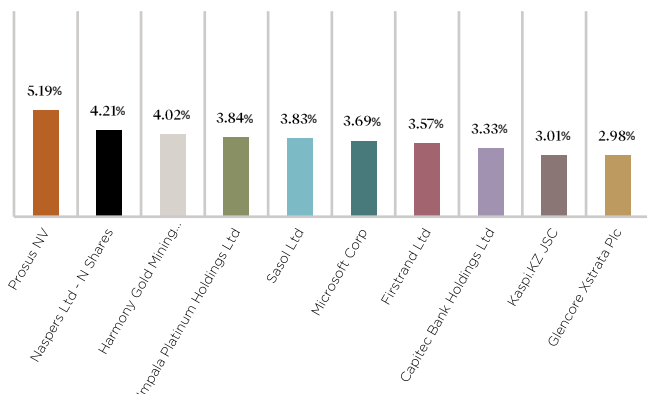

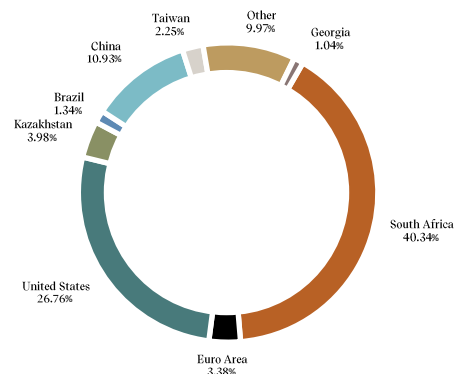

MARKET COMMENTARY

The fund returned -7.52% for the month, underperforming the benchmark by -5.41%. The JSE Capped All Share Index declined 3.7% over the month, while the MSCI ACWI Index increased by 0.38% (all in ZAR).

The underperformance of the fund can be attributed to two main themes: overweight PGM's on the local side and underweight Semiconductors on the global side, while being overweight Hyperscalers and Software and Platform companies.

Global equity markets consolidated in June as the strong run in AI and semiconductor stocks paused, and a more hawkish shift in rate expectations weighed on the sectors that had led the market higher. US equities were softer, with the S&P 500 down 0.95% and the Nasdaq declining 0.12%, as elevated valuations and a more cautious rates outlook tempered risk appetite. The Federal Reserve left its target range unchanged at 3.50% to 3.75% at its June meeting and adopted a more hawkish tone, signalling that a further hike was possible, which supported the US dollar. Geopolitics remained a key driver, with oil prices falling sharply as the conflict between the United States and Iran de-escalated and supply returned to the market. Brent crude declined 20.8%, retracing back towards pre-war levels, although renewed strikes late in the month were a reminder that the situation remained fragile. The US labour market stayed resilient, with May payrolls rising 172k and unemployment holding at 4.3%, reinforcing the Fed's patient stance. Gold fell 11.3% as safe-haven demand unwound and the dollar strengthened.

Emerging markets declined in June, with the MSCI Emerging Markets Index falling 1.4%, as a stronger US dollar and softer commodity prices weighed on sentiment and the AI and semiconductor rally paused after a period of strong gains. Performance diverged meaningfully on a country level. South Korea and Taiwan, which had led the rally in prior months, saw profit-taking across the semiconductor complex following a sharp single-day sell-off early in the month, with Korea declining 1.9% and Taiwan holding onto a modest 1.2% gain. Indonesia was the weakest market, falling 9.4%, as a record low rupiah, persistent foreign outflows and concerns over the fiscal deficit weighed on sentiment. China fell 7.1%, with a technology-led sell-off compounding the ongoing drags from a weak property market and subdued consumer confidence. South Africa declined 6.8%, tracking gold and other precious metals lower, which weighed heavily on its large mining sector. India and Turkey were among the few markets to advance, rising 1.5% and 1.4% respectively.

Notable portfolio actions during June included initiating new positions in Zijin Mining, the Chinese gold and copper producer, and Salesforce, taking advantage of a sharp sell-off across software stocks on fears that AI could disrupt traditional enterprise software, which left the shares on an undemanding valuation. The fund also added to Bid Corp and Prosus. The fund trimmed its platinum holdings in Impala Platinum, Northam Platinum and Valterra Platinum, along with Fortinet, reducing positions where the risk-reward or portfolio fit had become less compelling.

Notable contributors to fund performance were holdings in TSMC (+31 basis points) and Motus (+17 basis points). Notable detractors from performance over the month came from Impala Platinum (-111 basis points), Northam Platinum (-87 basis points) and Sasol (-81 basis points).

The fund's style and country positioning remain largely unchanged. The fund's current asset allocation to the JSE is around 56.4%, with the remainder invested in global shares.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

High Water Mark: The highest level of performance achieved over a specified period.

Performance Fee Cap: The maximum performance fee that can be charged over a specified period

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Specific Risk

The portfolio has adhered to its object and there were no material changes to the composition of the portfolio during the quarter.

Risk Indicator Definition

The Portfolio is more diversified than the benchmark, thus holding smaller positions in the largest capitalisation stocks than the benchmark. This comes with the risk of more volatile relative returns to the broader market when the largest stocks in the benchmark outperform. We believe however that this strategy of holding a more diversified portfolio results in lower single stock risk, and whilst there may be periods of underperformance when the large cap stocks rally, we firmly believe in efficient risk management on an absolute basis. The strategy is also exposed to various factors driving investment performance, for example Value and Momentum, and these factors may also experience periods of relative underperformance. Global research has shown however, that consistent long term exposure to these factors lead to investment reward. This portfolio is permitted to invest in foreign securities which may have additional risks (FX Movements for example). However, the portfolio does not currently hold any foreign securities and the manager does not intend on exposing the portfolio to any foreign securities going forward.
