

COMMENTARY

The CAEP Controlled CPI+5% Prescient Fund targets a 5% capital growth above inflation over a five-year rolling period. With the fund launched on 27 September 2024, it is too early to measure the achievement of its goals. The fund is, however, on track and has adhered to its well-balanced portfolio strategy, maintaining effective equity exposure within the 75% limit.

South African Economic Overview

Q3 2024: Moderate economic growth driven by consumer spending and manufacturing recovery (GDP +2.3%). Inflation stable at 5.0%, reportate at 5.5%.

Q4 2024: Continued growth with GDP at 2.1%. Agricultural sector boost, challenges from load shedding and political uncertainties. Inflation at 4.8%, reportate unchanged.

Global Economic Overview

Q3 2024: Global GDP growth at 3.0%. US interest rate at 5.75%, inflation 3.2%. Europe's GDP growth at 1.8% due to geopolitical tensions.

Q4 2024: Mixed global picture. US GDP at 2.8%, China's at 4.5%. Eurozone GDP at 1.6% affected by high energy prices and supply chain issues.
