The objective of this fund is to generate long-term capital growth and outperform the benchmark over a rolling three year period. The fund will have exposure to a broad range of markets across multiple asset classes, including both local and offshore investments. Underlying investments may include both actively managed and index-tracking strategies. The strategy is constructed with a medium allocation to equity.



Portfolio composition

The Cogence Moderate Prescient Fund of Funds is constructed as a diversified portfolio of funds spanning various asset classes, and across both active and passive strategies. Asset allocation and global manager selection advice is provided by BlackRock, while RisCura provide local manager selection.

During the fourth quarter of 2024, the portfolio's offshore (global ex-SA) allocation remained unchanged at 36.30%. SA cash and SA equity reference allocations were reduced by 1.30% and 1.00%, respectively, and redeployed into SA bonds. The local and global managers remained unchanged.

The portfolio remains within the defined risk parameters of a medium risk profile as per the ASISA category's maximum equity allowance of up to 60%.

Monthly market commentary

Despite a robust start to 2025, February brought a mix of declines and gains to equity markets, while positive performances fixed income markets delivered generally positive returns as yields fell in the month. Within equities, developed markets dipped by 0.9%, lead by losses in US equities which fell 1.6% while European equities excluding the UK saw a 3.4% increase in February, elevating their YTD gains to 10.8%. Trade tensions overshadowed the exceptionalism of the United States, acting as a significant headwind for equity growth. Japanese equities faced the steepest decline due to trade concerns and rising inflation. In contrast, European stocks experienced growth as investors shifted away from U.S. equities, with defence stocks soaring amid sustained geopolitical instability.

South African equities remained flat in February, influenced by the uncertainty surrounding the postponement of Finance Minister Enoch Godongwana's national budget speech. This delay was due to the coalition government's inability to agree on the proposed VAT increase from 15% to 17%. Additionally, the return of load shedding after a year of relatively stable power supply added to the market's concerns. The South African Reserve Bank (SARB) reduced its key interest rate by 25 basis points to 7.50%, marking the third consecutive rate cut. The central bank noted that while inflation appeared to be under control, the medium-term outlook remained uncertain. In January, the Consumer Price Index (CPI) rose to 3.2%, still below the SARB's 4.5% target, while core inflation dropped to 3.5%, its lowest level since February 2022. Producer inflation increased in January, reaching 1.1% year-on-year, surpassing market expectations. Finally, the Rand was broadly flat in February, despite a volatile environment, closing at around R18.69/\$ compared to R18.66 /\$ in February.

Yields

The yield for bond and income portfolios is historic and is calculated quarterly.

Important information

The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. NAV to NAV figures have been used for the performance calculations, as calculated by the manager at the valuation time of 16:00 as defined in the deed, over all reporting periods. Investment performance calculations are available for verification upon request by any person. Reinvestment of income is calculated on the actual amount distributed per participatory interest, using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. The performance is calculated for the fee class. The individual investor performance may differ, as a result of initial fees, the actual investment date, the date of reinvestment and dividend withholding tax. The rate of return is calculated on a total return basis, and the following elements may involve a reduction of the investor's capital: interest rates, economic outlook, inflation, deflation, economic and political shocks or changes in economic policy. Annualised returns are period returns re-scaled to a period of one year. This allows investors to compare returns of different assets that they have owned for different lengths of time. All period returns greater than one year have been annualised. Returns for periods less than one year have not been annualised. A cumulative return is the aggregate amount an investment has gained or lost over time, independent of the period of time involved. Actual annual figures are available to the investor on request. Glossary

Annualised return - An annualised return is the weighted average compound growth rate over the period measured.

Highest & Lowest return - The highest and lowest returns for any one year over the period since inception have been shown.

Volatility - Volatility (also called standard deviation) is a measure of how widely the returns varied over the period measured.

Maximum drawdown - A maximum drawdown is the maximum loss from a peak to trough of the portfolio over the period measured, before a new peak is attained.

Sharpe ratio - The sharpe ratio is a measure of risk-adjusted returns. The sharpe ratio reflectes the extent to which an investment compensates for extra risk.

NAV - The net asset value represents the assets of a fund less its liabilities.

What is the total investment charge (TIC)

Total expense ratio (TER) is the percentage of the value of the portfolio that was incurred as expenses relating to the administration (charges, levies and fees) of the portfolio. TER is calculated over rolling 3 years (or since inception, where applicable), and is annualised, to the most recent calendar quarter-end. A higher TER does not necessarily imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs (TC) is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction Costs are a necessary cost in administering the portfolio and impacts portfolio returns. It should not be considered in isolation, as returns, may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the TER. Calculations are based on actual data, where possible, and best estimates, where actual data is not available. Total investment charges (TIC) is the percentage of the value of the portfolio that was incurred as costs relating to the TER and TC.
