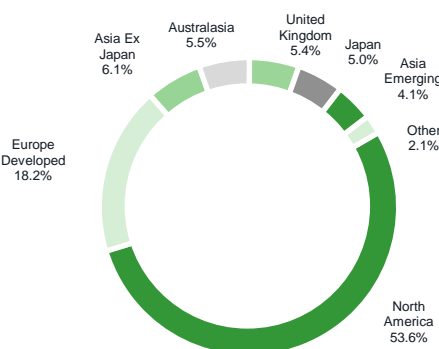

FUND COMMENTARY

The global economy has proven remarkably resilient over the last few years, surviving the pandemic, and ploughing on despite the war in Europe, energy price and supply side shocks, geopolitical tensions, high inflation and record high interest rates. Despite the current slow-down in global growth, such durability provides comfort for the future. With inflation seemingly back under control, interest rates set to come down and labour markets still strong, there are good reasons to be optimistic about the future, even if markets appear to have discounted much of that already. The markets ended 2023 with an astonishing two-month rally, as investors bet that the big central banks will cut rates aggressively next year. In consequence, the MSCI World Index surged 16% from late October and finished the year up 22%. In the US bond market, yields went on a round trip in 2023. The 10-year, which serves as a global benchmark started the year at 3.8% and mostly traded below 4% until August. It then spiked up to a 17-year high of 5% but recovered just as quickly on moderating inflation and jobs data, and, in December, on the Fed's pivot to rate cuts in 2024. In consequence, the 10-year finished the year almost where it started (3.86%), with the yield falling a massive 56bp in December.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.
