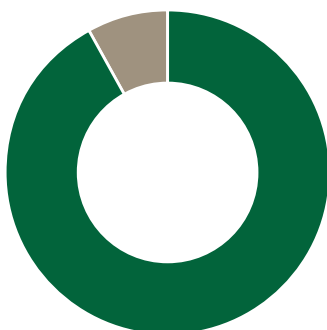

## QUARTERLY FUND COMMENTARY (AS OF Q2 2025)

The second quarter of 2025 was shaped by a complex interplay of domestic resilience and global recalibration.

Domestically, South Africa benefited from subdued inflation (headline CPI at 2.8% in May), a supportive monetary policy shift (repo rate cut to 7.25%), optimism around fiscal consolidation, and accelerating infrastructure investment with Operation Vulindlela in its second phase.

Globally, markets were shaped by a shift in US trade policy. While initial tariff shocks under President Trump unsettled investors, a move toward negotiation helped ease uncertainty. The US dollar weakened sharply—down 10.7% year-to-date—prompting a reassessment of global asset allocations.

Gold, a key South African export, surged 24.4% in USD terms, improving South Africa's terms of trade and supporting a 3.5% appreciation in the rand.

South African bonds delivered a strong return of 5.9% for the quarter, outperforming cash (1.8%) and reflecting renewed investor confidence in the country's fiscal trajectory. The yield on the 10-year government bond declined to 10.0%, from 10.6% in Q1, supported by a more constructive global risk environment, growing optimism around a potential recalibration of the SARB's inflation target, and continued fiscal discipline. The government's primary budget surplus—estimated at 0.7% of GDP for FY2024/25—further reinforces the credibility of its fiscal consolidation path.

We continue to view SA government bonds as close to fair value, offering attractive real yields in the context of subdued inflation. Our portfolio remains positioned to benefit from this environment, with a tilt toward cash and money market instruments that continue to offer compelling real returns, while maintaining selective exposure to longer-duration assets.

During this time, he managed a range of portfolios including hedge funds, long-only absolute returns funds as well as an equity fund. He also has a number of years' experience doing structuring for South African institutional and corporate clients. Bryn served on the Financial Derivatives Advisory Committee for the South African Futures Exchange (SAFEX) for over 10 years. He is a qualified Chartered Accountant as well as a CFA charterholder and studied Business Science at the University of Cape Town.

## GLOSSARY SUMMARY

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Alpha:** Denoted the outperformance of the fund over the benchmark.

## FUND SPECIFIC RISKS

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Max Gain:** Largest increase in any single month
