The objective of the CAEP Venture CPI+7% Prescient Fund aims to deliver above average growth of capital on an inflation-adjusted basis, over the long term through a flexible mandate which can invest in all asset classes, both locally and globally.

The CAEP Venture CPI+7% Prescient Fund will provide a solution to investors who have a long-term investment horizon and who require capital growth.

FUND UNIVERSE

The Fund is comprised of local and worldwide funds and exchange traded funds to achieve its investment objectives, as well as investments into a combination of equities, listed property, bonds, notes and assets in liquid form, both locally and globally. This portfolio may be aggressively managed with assets being shifted between the various markets and asset classes to reflect changing economic and market conditions. The portfolio is permitted to invest in listed and unlisted financial instruments in line with the conditions as determined by legislation from time to time.

The CAEP Venture CPI+7% Prescient Fund is a high-risk multi-asset class, flexible solution targeting CPI+7% over a rolling 7-year period.

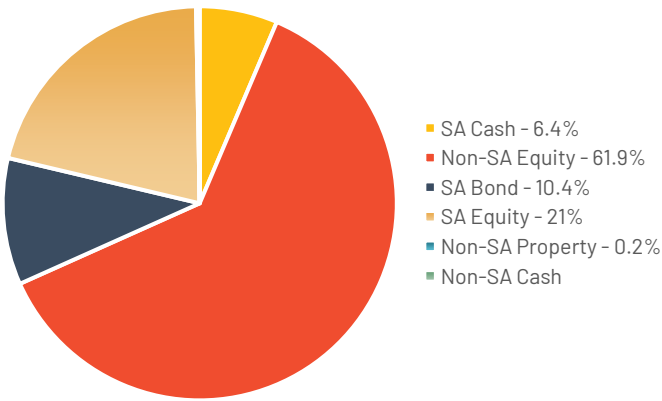

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Average Credit quality: The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

High Water Mark: The highest level of performance achieved over a specified period.
