ABOUT THE FUND

The Fund is actively managed on a discretionary basis to provide stable long-term growth with moderate level of risk. The Fund shall be within 2 years of the modified duration of the BEASSA Total Return Index.

INVESTMENT STRATEGY

The Fund aims to deliver a return in excess of the benchmark over the long term, which comprises a reasonable level of income, as well as capital performance relative to the benchmark. The portfolio will invest in interest bearing and non-equity securities (including, but not limited to, government or quasigovernment bonds, corporate bonds, cash deposits, money market and other interest-bearing securities), as well as listed and unlisted financial instruments in line with appropriate regulations. The investments are actively managed and will change over time to reflect a macro fundamental outlook including the interest rate cycle, business cycle, default cycle, as well as other cyclical and credit factors.

The portfolio has adhered to its investment objective and there were no material changes to the composition of the portfolio during the reporting period.





FUND COMMENTARY

The South African yield curve effectively flattened in February despite heightened levels of global risk aversion. The local currency is still underperforming peers, having topped R19 to the US Dollar since the February Budget. SAGBs have also underperformed peers owing to persistent concerns about policy direction, which is exacerbated by the potential impact that the election result could have. Furthermore, the weak commodity backdrop is unsupportive and a key risk to the currency forecasts.

Now that the Budget is out of the way, we expect SA investors to focus on this month's Fed and SARB MPC meetings. Critically, the Fed will be updating its dot plot and giving its latest economic projections at this month's meeting. If the market interpretation is that Fed is more dovish, the rand and other emerging market currencies could enjoy a fresh rally. However, should the Fed instead maintain a wait-and-see approach, then EM currencies are likely to remain in a holding pattern. EM bulls will also be hoping for a significant stimulus package out of China, when the PBoC has its next meeting in April. Offshore remain net sellers of SAGBs while locals still carry the bulk of the burden of funding the fiscus but increasingly demanding higher yields.

GLOSSARY

- Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
- Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.
- NAV: The net asset value represents the assets of a Fund less its liabilities.
- Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
- Standard Deviation: The deviation of the return stream relative to its own average.
- Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.
- Max Gain: Largest increase in any single month
- % Positive Month: The percentage of months since inception where the Fund has delivered positive return.
- Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.
- · Average Credit quality: The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).
