WHO SHOULD INVEST



RISK INDICATOR DEFINITION

These portfolios typically target returns in the region of 3% - 4% above inflation over the long term.





FUND COMMENTARY

In March, the Federal Reserve maintained interest rates as anticipated and indicated its intention to implement multiple cuts before the year's end. The central bank decided to keep its benchmark overnight borrowing rate within the range of 5.25% to 5.5%, a range unchanged since July 2023. Additionally, the Fed projected three quarter-percentage point cuts by the end of 2024, marking the first reductions since the early stages of the Covid pandemic in March 2020.

Meanwhile, inflation in the Eurozone, comprising of 20 nations, eased to 2.4% in March, a figure lower than expected. This decrease in inflation raised expectations of the European Central Bank (ECB) initiating rate cuts before the United States, where inflation remains above 3%.

As markets anticipate rate adjustments in Western economies, the Bank of Japan (BOJ) in Asia raised interest rates for the first time since 2007, putting an end to the negative interest rate environment in the country. The new rates now stand between 0% and 0.1%. Although there was speculation in the market regarding the BOJ's move, the timing remained uncertain.

Furthermore, gold prices reached another record high last month, driven by expectations of U.S. interest rate cuts and the metal's perceived value as a safe haven asset. Gold prices typically exhibit an inverse relationship with interest rates; as interest rates decrease, gold becomes more attractive compared to fixed-income assets like bonds, which offer weaker returns in a low-interest-rate environment.

March marked the end of a successful first quarter for global equities, driven by enthusiasm surrounding technology and AI chips, as well as anticipation of central banks normalizing interest rates. The MSCI World Total Return Index climbed steadily over the first three months of the year, achieving an impressive 8.9% increase in Q1. Notably, Japan's Nikkei index outperformed other developed indices, soaring by more than 20%. Similarly, the S&P500 Total Return Index also recorded substantial gains, exceeding 10%. European indices also experienced favourable returns. While emerging markets saw growth, it was less pronounced compared to developed markets, with the MSCI Emerging Markets Total Return Index registering a modest 2.4% increase. On the bond front, global bonds saw a decrease of -2.1%, as expectations for rate cuts were delayed due to persistent inflation in certain sectors.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
