INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the FTSE/JSE Africa Capped Shareholder Weighted Total Return Index at low cost. Although the Fund is structured similarly to the Capped SWIX, it can out / underperform the Capped SWIX by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment policy which firstly endeavours to follow the composition of the Capped SWIX closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. In addition to investing in physical assets, the Fund can use derivatives to create exposure to the Capped SWIX or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST

Investors who are seeking long term capital growth through exposure to the South Africa equity market by investing in a fund with a low tracking error relative to the Capped SWIX and who are cost conscious.


RISK INDICATOR DEFINITION



FUND COMMENTARY

Trade policy uncertainty, slowing growth expectations and monetary policy recalibration took centre stage during this year's first-quarter market performance exhibition. Developed market equities, with the MSCI World Index down 4.45% and 1.79% for the month and quarter respectively, were dragged lower by the US to close behind the broad emerging markets as the MSCI Emerging Markets Index closed 0.63% and 2.93% higher for the month and quarter. Largely solid quarterly earnings growth numbers reported in the US were overshadowed by a looming tariff-shaped trade war cloud hovering directly over economic growth prospects and potentially resulting in higher prices and elevated interest rates. In what was its worst month in over two years, the S&P 500 Index gave back 5.63% for the month to close the quarter 4.27% lower.

European markets, on the other hand, have continued to advance on the back of an improved fiscal outlook - particularly on infrastructure and defence spending - which together with two interest rate cuts delivered by the ECB during the quarter, helped the Euro Stoxx Index post impressive gains of 0.92% for the month and 12.49% for the quarter. Asian markets, overall, have been underwhelming this period. The stronger Japanese yen continued to hamper that equity market as the Nikkei 225 Index closed 3.84% and 6.40% lower for the month and guarter. Despite some excitement towards China's technology sector, mainland shares closed the guarter lower with the CSI 300 Index down 2.21% and 0.64% for the month and guarter.

Despite the widening cracks in the Government of National Unity over the country's fiscal framework and significant downward revisions to the rate of monetary policy easing, the domestic equity market continued to make new highs as valuations and business sentiment remained favourable. The FTSE/JSE All Share Index posted solid returns, up 3.55% for the month to close the quarter 5.94% higher. The resources sector was the standout sector with the index advancing 19.54% and 32.26% for the month and quarter respectively.

The Fund has delivered returns in line with, and marginally behind the benchmark index over the last month. This performance is in line with the investment process and systematic risk managed investment philosophy employed to deliver consistent long-term outperformance.

We remain moderately positive on SA equities with a marginally weaker valuations indicator as the market continues to re-rate higher. Our US equity outlook has moved further into moderately negative, underpinned by deteriorating economic and sentiment indicators.

The Fund maintains the maximum effective exposure to the large- and mid-cap sectors of the market. This equity exposure consists of top three allocations to the financials, basic materials, and technology sectors, with the largest share exposures to Naspers, FirstRand Bank, and Gold Fields.

The top contributors to the Fund's performance in March were Gold Fields (26.70%), AngloGold (33.43%) and Harmony Gold (47.86%). Detractors included Richemont (-15.13%), Anglo American (-5.39%), and Nedbank (-8.06%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.
