INVESTMENT AND RETURN OBJECTIVE

The Fund aims to generate real returns in US Dollars and is benchmarked to the US inflation rate.

The investment universe includes fixed, floating, real and nominal money market and bond market investments, derivatives and global currencies. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes, the use of derivatives and currency management.

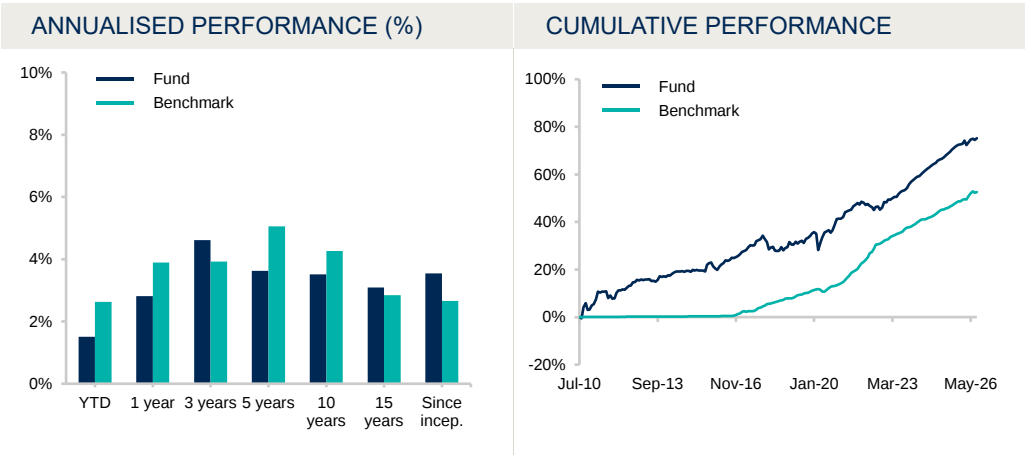
WHO SHOULD INVEST

Investors seeking a hedge against any rand depreciation while gaining exposure to high yielding offshore assets that are not available locally in South Africa. Although this is a roll-up fund and does not distribute income, it is suitable to investors with a medium to long-term investment horizon who wishes to fund income withdrawals by redeeming units, due to the exposure to yield generating assets held in the Fund and therefore a lower probability of selling underlying units at inappropriate times such as in a market downturn.

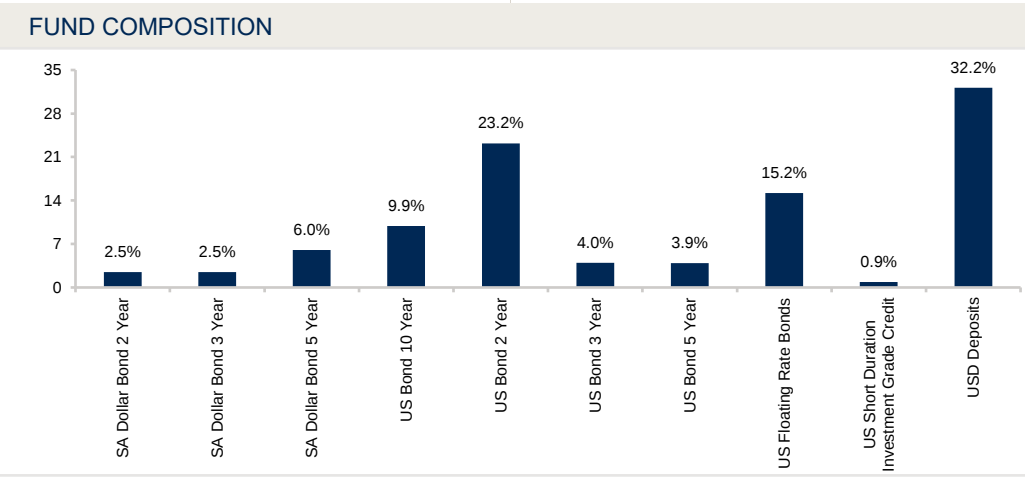
RISK INDICATOR DEFINITION

This portfolio typically has no equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses in USD terms over the shorter term unlikely. This portfolio typically targets a return in the region of 1% – 3% above US inflation over the long term.

FUND COMMENTARY

With no scheduled FOMC meeting, August's focus fell on the Jackson Hole symposium, where Fed Chair Kevin Warsh struck a firmly hawkish tone. Reaffirming that "the Fed's price-stability objective of 2 percent... is a firm, fixed target," he warned that the Committee "must be confident that underlying inflation is moving to our objective... otherwise, we have work to do" — remarks analysts read as raising the odds of a September hike and setting the central bank at odds with a Treasury pressing for lower yields. Bond and dollar markets traded on edge into the speech.

The energy backdrop kept the inflation debate live. The US–Iran confrontation over the Strait of Hormuz dragged on, with Washington maintaining sanctions on Iranian crude; Brent rose above \$90 from an intramonth low of just \$80 through the month, briefly sliding around 2.5% on 24 August before recovering, while a phased Iran–Oman corridor framework and gradually rising Gulf exports late in the month limited the upside. Against sticky energy and hawkish guidance, the US 10-year Treasury yield backed up to 4.73% and the front end stayed anchored but volatile.

The Fund closed August with a gross yield of 4.35% (NACA, against a US CPI + 1% benchmark) and a modified duration of around 1.51 years, its emphasis on high-quality carry and short-dated credit continuing to contain mark-to-market swings as core yields drifted higher while limited duration protected capital. With the Fed leaning hawkish, energy prices elevated and the Hormuz dispute unresolved, positioning remains conservative — prioritising yield capture over directional rate risk, while retaining the flexibility to add duration should the September meeting or a genuine easing in oil confirm a disinflationary turn.

The Fund delivered a positive return for Aug and was ahead of its benchmark. The duration assets helping the Fund for the month. The Money Market exposures added positively.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
