INVESTMENT OBJECTIVE

The portfolio will aim to maximize total return for investors by way of a flexible worldwide portfolio actively investing across equities and cash, both locally and internationally.

The Fund has adhered to its policy objective.

We invest in best of class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

The recovery in world stock markets since the 8 April announcement of the tariff negotiation period continued in August, following the relatively rare occurrence of May, June and July experiencing positive returns. The initial relief rally has evolved into a fundamental based one with US second quarter GDP revised upwards to +3.3%, a strong second quarter reporting season, attempts to make progress on resolving the Ukraine war and the Jackson Hole meetings with the Fed Chair indicating that he is slowly becoming more dovish. The market concluded that the next Fed rate cut is getting closer.

The benefits of the weaker US dollar started materialising in the second-quarter US reporting season, which is now almost done, with S&P 500 Index Revenue and Earnings respectively growing +6% and +12%, respectively reflecting +2% and +8% upside surprises. Along with this, margin expansion continued, particularly amongst the technology leaders.

The best contributors to fund performance have been Alphabet, Copart and ASML. The common theme between Alphabet and ASML is the AI boom that has been a dominant feature of the reporting season. This was well reflected in the semi-conductor and cloud sectors. Further to this, Alphabet is demonstrating stronger than expected AI capability with their Gemini developments, and has won cloud business from peers Open AI and Meta. ASML benefitted from customers making spending commitments. Copart is turning for the better after a severe sell-off.

The largest detractors from performance have been Microsoft, Eaton and Amazon. Microsoft's share responded well to the particularly strong growth in its Azure cloud business, but the stock subsequently drifted lower due to profit taking and some reservations around its strategic relationship with Open AI. Eaton reported good results, but disappointed in its outlook statement. Amazon had in essence flat stock performance following AWS's growth in line with expectations.

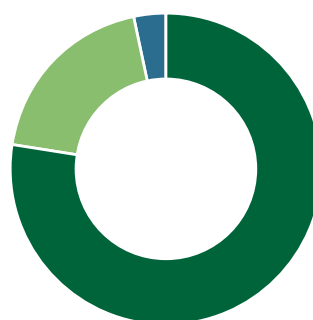
