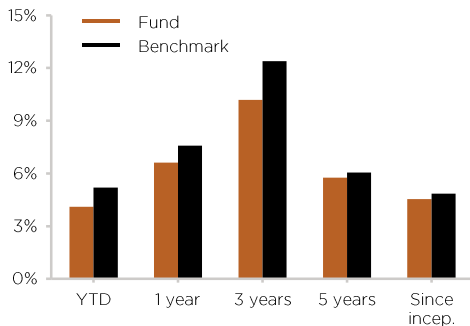
Risk Indicator Definition

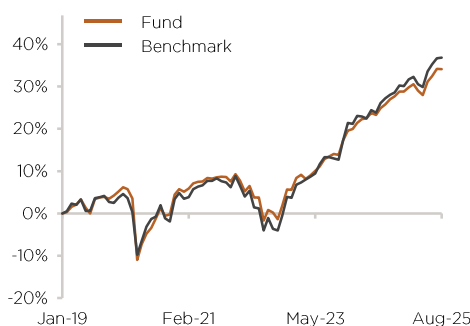
RISK INDICATOR

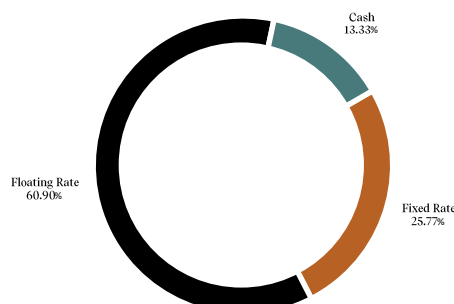

MARKET COMMENTARY

Market Dynamics:

European credit markets stalled during August with the iTraxx Crossover 5-year spread index ending precisely where it started, i.e. at 268 basis points (bps). We highlighted in last month's piece that August is typically a pedestrian month for European markets, as the northern hemisphere is usually on traditional summer holidays. So, markets did slow down, volatility decreased. The iTraxx Crossover traded a very narrow range between 280 – 260 bps whilst the total return index languished, producing a rather meagre 12 bps.

Looking at the default side of the credit coin, August was yet another default-free month in the international credit market. The recovery auction for Altice France was held on the 27th of August, and the auction resulted in a recovery of 87.75%, or only a 12.25% loss on the default. This was higher than was highlighted in last month's piece, where we cited the bonds trading in the 75% context.

During the month, the fund (A-class) lost some 0.07% on an after-all-fees basis, marginally underperforming the benchmark.

Looking to September, it's a busy month regarding central banks with the European Central Bank (11th), the Federal Reserve (17th) and the Bank of England (18th) all announcing their decisions on short-term administered rates. Of the three, the Federal Reserve looks the most likely to cut rates by 25 bps.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

High Water Mark: The highest level of performance achieved over a specified period.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Specific Risk
