
Growth (Net of fees) of USD100 invested at inception.





/ Relative performance

During the quarter, risk assets recovered from the volatility experienced at the beginning of April due to the US tariff hike announcements. Against this backdrop, the Fund generated a return of 5.28% compared to the return of 5.78% for the EAA Fund USD Flexible Allocation category. This positive performance was generated as all the underlying asset classes generated a positive return for the Fund. The contribution to return of the Fund's property exposure was 1.61%. The equity portion contributed the most to the performance over the period amounting to 4.35%. This is equivalent to an equity exposure holding period return of 8.03%, behind the MSCI All-Country World Index total return of 11.53%. The Fund was negatively impacted by 1.59% from its derivative options exposure which is a means to hedge against a potential downturn in the global equity market. Commodity exposure contributed 0.84% as the performance of platinum outweighed the muted performance of gold and silver during the period. Bond exposure contributed 0.02% to total return whilst cash return was 0.21% as the Japanese yen appreciated against the dollar. With the improved Q2 2025 figures, the Fund continues to be well positioned to take advantage of the outlook for global assets for the rest of the year given the macro-economic and geopolitical backdrop.

/ Fund composition

Over the quarter, the Investment Manager maintained the Fund's risk asset exposure below the strategic allocation weight as market valuations remain stretched. The Fund's property exposure was reduced with a partial redemption of the Clearance Camino Fund and disposal of the iShares European Property ETF. Additionally, the Fund's commodity exposure was maintained to continue benefiting from its diversification characteristics. Although gross equity exposure rose this quarter, net exposure remained well below its strategic weight. For continued downside protection, the Investment Manager rolled over the Fund's options overlay on the S&P 500 index. Lastly, exposure to investment grade bonds was removed through the redemption of the PIMCO Global Investment Grade Credit Fund.
