


RISK INDICATOR







MARKET COMMENTARY

The Fund returned 2.76% for the month, underperforming the benchmark by 1.67%. Global markets had a strong February, with the S&P Global 1200 Index increasing 4.4%, the MSCI ACWI climbing 4.2% and the MSCI Emerging Markets Index rising 4.6% (all in USD).

Notwithstanding the US inflation print that came in higher than expected, the US market continued to advance through the month on strong earnings reported by corporates, as well as supportive economic data. The Chinese market was the best-performing market over the month rising 8.4%, following announcements by regulators to curb short selling and state investors expanding their stock buying plans. On a sector level, returns were driven by Consumer discretionary (+8.2%), where the Fund is overweight, however, Information technology increased by 6.2%, where the Fund is underweight.

Noteworthy portfolio actions include selling out of the holdings in Heineken, Nitto Denko and Hershey, while the exposure to the technology sector was increased by topping up Google, Samsung Electronics, Kaspi, Qualcomm and Amazon. New positions were initiated in Starbucks and TBC Group, while Coca-Cola, JD Sports and John Deere were also topped up.

Notable contributors to Fund performance were positions in Kaspi (+68 bps absolute and relative), Evolution AB (+44 bps absolute and relative), Meta (+34 bps absolute, -6 bps relative) and Crocs (+24 bps absolute and relative). Notable detractors from performance over the month came from Glencore (-14 bps absolute, -13 bps relative), InMode (-14 bps absolute and relative) and Anglo American (-10 bps absolute, -9 bps relative), while an underweight holding in Nvidia detracted 50 bps from relative performance following a strong set of quarterly results.

The Fund's positioning remains largely unchanged, with an overweight position in the defensive names and underweight in cyclicals, as we are cognisant that the higher interest rates will eventually lead to a slowdown in economic activity. The Fund remains overweight Chinese technology shares, as some of these names are trading on single-digit price/earnings ratios and sitting on net cash as a percentage of market cap north of 50%. We are underweight US technology shares as we do not believe the risk-reward is attractive at these levels.

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Performance Fee Cap: The maximum performance fee that can be charged over a specified period

Specific Risk
