

## Investment Objective & Strategy

The **WealthStrat Growth Prescient Fund of Funds** will aim to deliver moderate to high long term total return. The manager shall have limited flexibility in terms of asset allocation and shall not be precluded from continually varying the underlying exposure to both local and offshore assets. The Fund will employ asset and limited geographical allocations to reflect changing economic and market conditions to maximise returns over the long term, the **WealthStrat Growth Prescient Fund of Funds** will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The equity allocation will be managed at a maximum effective exposure, including offshore equity, up to 75%. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The underlying portfolios will predominantly invest in South African markets but is however permitted to include investments in offshore jurisdictions subject to the investment conditions determined by legislation from time to time.

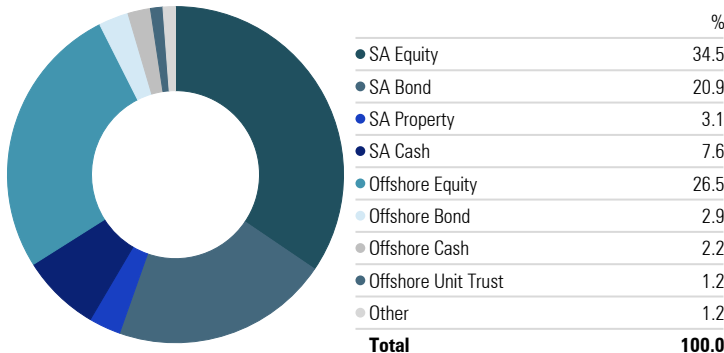

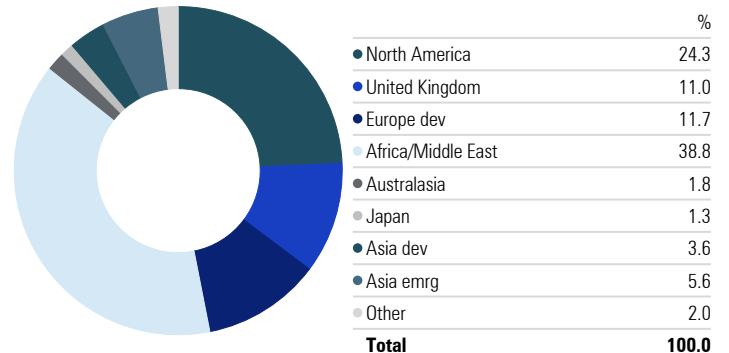
## Asset Allocation

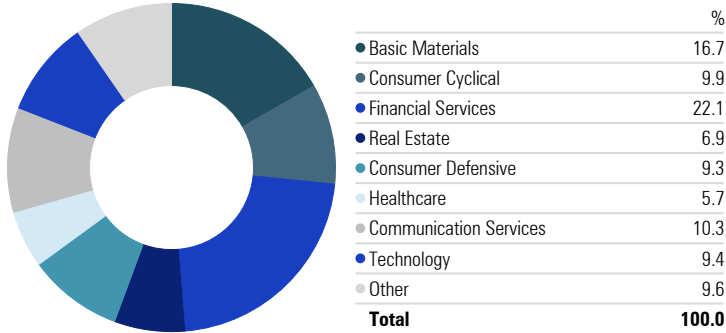

## Quarterly Fund Commentary

Moderately aggressive investors generated robust returns in the fourth quarter of 2023, as most risk assets recorded strong performance. Strong returns from both global and local equities acted as a tailwind to the performance of the Portfolio over the quarter. The firmer rand, however, acted as a headwind to the performance of global asset classes over the quarter.

The WealthStrat Growth Prescient Fund of Funds returned +6.7% for the quarter and has generated a return of +13.5% over the past year.

The Portfolio remains diversified in terms of its exposure to different asset classes, and we remain confident in its ability to deliver inflation-beating returns over the long term, independent of the market environment.

### Asset Allocation

Local equities ended the quarter higher, and ended the year in positive territory, however, they lagged the broader emerging market complex. The strength in SA equities was largely driven by the Financials (+11.8%) sector, which ended the quarter posting double digit returns and is the best performing sector for the 2023 calendar year. Index heavyweights Capitec (+19.2%) and Firststrand (+18.8%) both ended in positive territory. Resources (+3.0%), while posting a positive quarter, lagged other sectors, as continued pressure on platinum and energy stocks dampened the return for the sector. Sasol (-29.0%), Impala Platinum Holdings Ltd (-7.7%) and Thungela (-11.4%) all recorded declines over the quarter. On the other hand, gold and iron ore exposed resource companies produced strong returns, as both metal prices moved higher over the quarter. Industrials (+5.9%) produced a positive return this quarter, however, the sector lagged the broader market. The positive return masked the volatile nature of the sector this quarter, on the back of movements in two of the larger listed industrial counters; Prosus and Naspers. Global equities had a robust quarter, with most equity markets ending in positive territory. Given the risk on environment, 10 of the 11 major sectors delivered positive returns for the quarter, with energy the only sector to record a negative number on the back of a falling oil price. Most global equity markets produced strong hard currency performance this quarter, with the rand providing a headwind to performance. Local bonds make up the next largest allocation within the Portfolio. This includes allocations to corporate, government and inflation-linked bonds. Short dated nominal bonds held up well over the quarter and produced a stable performance over the 2023 calendar year. Longer-dated instruments ended the quarter higher, as the yield curve shifted lower, with the longer dated part of the yield curve falling the most. The strength in the SA bond market was largely on the back of the risk on environment that led to an increased appetite for emerging market asset classes. All eyes will be on the upcoming budget speech scheduled for February, which will provide an update on the state of government finances. Local cash allocations managed to deliver positive returns this quarter, slightly behind most other asset classes. Offshore bond and cash allocations contributed to performance as global fixed income markets produced a strong performance in the final quarter of 2023, benefiting from the anticipated interest rate cuts by the US Federal Reserve in 2024. The firm rand, however, acted as a headwind to the performance of offshore allocations. A small allocation to local listed property contributed to performance this quarter, as the property sector produced a robust performance, as the risk on environment coupled with strong performance from the larger listed players Growthpoint (+18.2%) and Redefine (+15.8%) led the sector higher. The fund's asset allocation is broadly similar to the previous quarter.

### Fund Selection

The contribution from fund selection was all positive over the quarter.

Aylett Equity Prescient Fund produced a strong return for the fourth quarter, ahead of the fund's benchmark and peer group average. The fund's offshore equity holdings produced strong gains and contributed positively to the performance this quarter. Holdings in Spirit AeroSystems (+91.0%), and Bath and Body Works (+24.8%) were the largest contributors from a global perspective. Local listed holdings in Transaction Capital (+90.0%), BHP (+17.0%) and Reinet Investments (+12.1%) also added to performance this month. On the other hand, holdings in Anglo American (-9.9%), British American Tobacco (-6.4%) and Impala Platinum (-7.7%) were among the larger detractors this quarter.

The Nedgroup Investments Global Emerging Markets Equity FF demonstrated resilience as an Emerging Market fund in a challenging market environment. Despite the strenuous conditions, the fund held up relatively well. The primary contributors to its performance were the exposures to the Technology sector, specifically with investments in TSMC and Samsung Electronics, as well as the Financial Services sector, notably with positions in Bank Pekao. However, it's important to note that the fund faced challenges stemming from its exposure to Chinese companies, including Tencent, Alibaba, and NetEase. The impact of these Chinese investments became the largest detractor from overall fund performance over the quarter.

Fairtree Equity Prescient Fund produced a strong return this quarter but lagged behind the South African Equity General Sector ending in the third quartile. The fund's exposure to SA resource companies such as Anglo American (-11.8%), Impala Platinum (-7.7%) and Thungela Resources (-11.4%) held the fund back this quarter. On the other hand, exposure to gold miners contributed positively to performance this quarter on the back of a strong bounce in the gold price. Gold Fields (+35.3%), Harmony Gold (+69.9%) and AngloGold Ashanti (+14.8%) all contributed to performance this quarter.

There were no changes made to the underlying funds in the Portfolio in the fourth quarter.

### Summary

We are pleased that the Portfolio managed to generate a strong return over the fourth quarter in a particularly strong global and local environment. The Portfolio continues to be allocated to a diverse range of attractively priced local and global asset classes and we are confident that it will be able to deliver on its objective over the long term. The fund has adhered to its policy objective.

**Glossary**

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month

**Fund Specific Risks**
