WHO SHOULD INVEST




RISK INDICATOR DEFINITION



FUND COMMENTARY

June saw the positive momentum gained in the back end of May continue, as the South African yield curve bull flattened during the month. This saw strong returns for South African fixed income markets. A key driver being the SARB's proposal on moving its inflation target down to a point target of 3%.

In June, the Federal Open Market Committee (FOMC) opted to keep the federal funds rate unchanged. This decision reflects the solid underlying economic growth in the U.S., balanced against ongoing uncertainty about the future impact of trade policies on the economy and inflation. Geopolitical tensions in the Middle East had been rising; however, a ceasefire has now been agreed upon and markets have responded positively to this development.

On the local front, we saw headline CPI inflation remained steady at 2.8% year-over-year in May, while core CPI inflation came in slightly below expectations at 3.0% versus a consensus forecast of 3.1%.

Given the movement in the SA yield curve, we continue to favour floating rate exposure in the 3-year segment, while concentrating our fixed rate exposure in the 10-year segment where we see the greatest value relative to the associated risk. With credit spreads continuing to tighten, and latest Bank AT1 credit remaining firm, we have preferred floating rate assets with underlying government exposure, thereby reducing the overall credit risk in the Fund.

The Fund's forward yield remains attractive at 9.47%. The Fund has an interest rate duration of 1.08 years and a total fund duration (including ILBs) of 1.20 years. The current risk profile aligns with the Fund's risk objective and we believe the Fund is well positioned to achieve its return objectives.

The Fund had a strong performance in June outperforming its benchmark. Key contributors were the good yielding assets in the portfolio and our preferred duration bond, the R2032. There were no detractors during the month.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
