



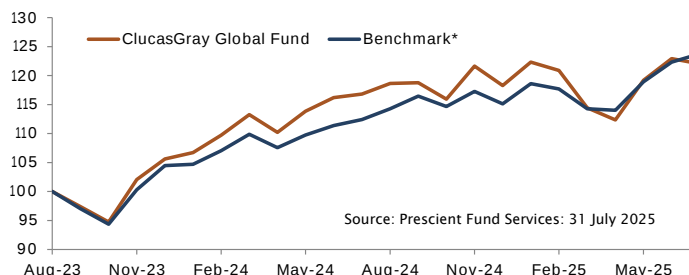
FUND OBJECTIVE & STRATEGY

The investment objective of the Fund is to provide long term capital appreciation and income growth through investment in a concentrated portfolio of assets. The fund is primarily exposed to a focused portfolio of developed market equities. The fund is managed on the basis of the long term ownership of assets and has a bias towards high quality ideas. Investors with a time horizon of three to five years are ideally suited to this fund.

MONTHLY COMMENTARY

The ClucasGray Global Fund declined 0.7% in July, while the Morningstar Aggressive Allocation peer group rose 1.2% and the MSCI All Country World index advanced 1.3%.

With Q2 earnings season in full swing, global equity markets posted modest headline gains in July, though underlying sector and regional performance varied significantly. US markets led the advance with the S&P500 gaining 2.2% and the tech-heavy Nasdaq rising 3.7%. The US dollar posted its first monthly gain this year, rising 3.2%. European markets traded broadly lower in USD terms amid persistent trade uncertainty, as the bloc reached a last-minute agreement with the US just days ahead of the 1 August deadline.

Growth-led sectors such as Information Technology (+4.1%) and Communication Services (+1.7%) outperformed, buoyed by robust earnings from large-cap technology firms. Accelerated growth trajectories and upbeat guidance further fueled enthusiasm around AI and cloud infrastructure as dominant investment themes. In contrast, traditionally defensive sectors like Healthcare (-2.7%) and Consumer Staples (-2.7%) underperformed. Healthcare was dragged lower by sharp sell-offs in key sector companies following significant cuts to earnings guidance, while Consumer Staples faced pressure from sluggish volume growth.

The Fund's largest positive performance came from Thermo Fisher Scientific (+15.3%), which raised guidance on a more benign tariff impact and a recovery in key end-markets. Nvidia (+12.6%) also delivered strong gains supported by the accelerating capital expenditure plans of its cloud infrastructure customers. Recently added Evolution AB (+12.5%), a provider of online casino technology, contributed positively after reporting better-than-expected results. The Fund's largest detractor was Novo Nordisk (-31.8%), which tumbled after once again lowering sales expectations for its weight-loss pill, citing market share erosion in the US. UnitedHealth (-16.5%) also declined sharply after new management reset earnings guidance to reflect a significantly more challenging operating environment.

During the month, the Fund initiated new positions in Accenture, a leading global consulting and technology services firm, and Salesforce, the dominant global provider of customer relationship management software. Both companies offer compelling growth profiles and currently trade at a meaningful discount to the broader IT sector. The Fund exited its position in UnitedHealth after the earnings report raised questions on management credibility and earnings quality, while the outlook for the company remains highly uncertain.

At the end of the month, the Fund had an underlying exposure to equities of 96.9%, and 3.1% cash.



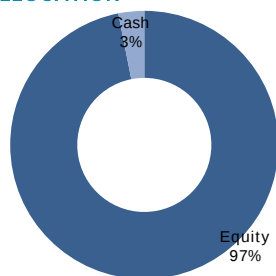

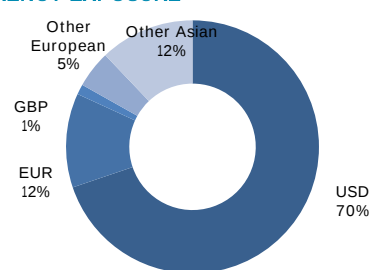

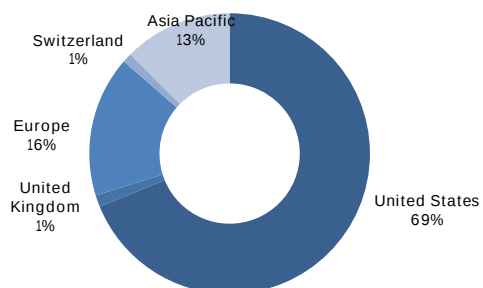
FUND ASSET ALLOCATION



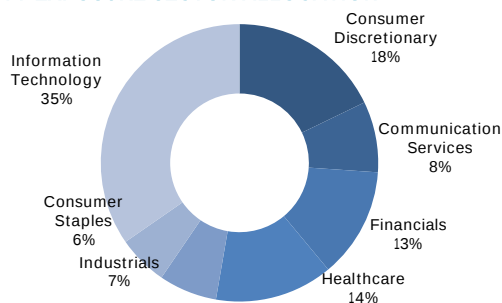
NET CURRENCY EXPOSURE

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.
